WHEREAS, the Board of Supervisors desires to implement the two (2) percent COLAs scheduled for the first full pay period in January 2023, early effective December 25, 2022, for all classifications in Management and Confidential (Units 8 and 9); and

WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

#### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS:

- The two (2) percent COLAs scheduled the first full pay period in January 2023, shall be implemented early effective the pay period beginning December 25, 2022, for all classifications in Management & Confidential Units 8 – 9.
- Resolution No. <u>22-188</u> is approved amending the Compensation Plan between the County of Humboldt and designated Management & Confidential Employees for Units 8 & 9.
- 3. The amended December 25, 2022 Comprehensive Compensation Schedule is adopted.
