**AMENDING SECTION 311-7 OF THE HUMBOLDT COUNTY CODE BY REZONING  
PROPERTY IN THE ETTERSBURG AREA [ZBA-18-001 (FRENCH)]**

**ORDINANCE NO. 2631**

The Board of Supervisors of the County of Humboldt ordains as follows:


**SECTION 1. ZONE AMENDMENT.** Section 311-7 of the Humboldt County Code is hereby amended by reclassifying the property described in the attached Exhibit A as follows: approximately six acres of Unclassified (U) into Timberland Production Zone (TPZ).

The area described is also shown on the Humboldt County Zoning maps [K-46] and on the map attached as Exhibit B.

**SECTION 2. EFFECTIVE DATE.** This ordinance shall become effective thirty (30) days after the date of its passage.

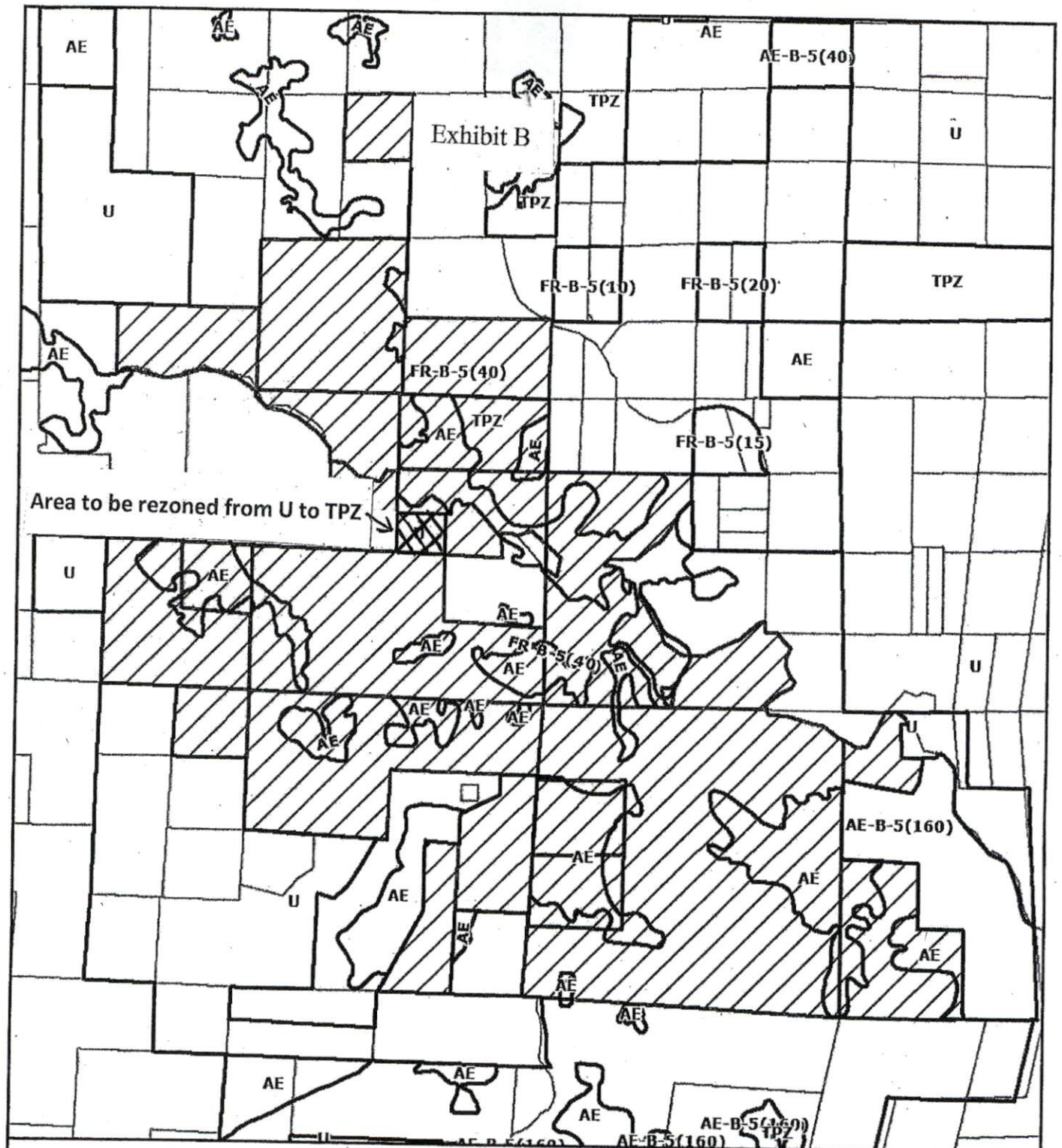

Exhibit A

Legal Description

That certain parcel being in the Southwest Quarter of the Northeast Quarter of Section 1 of Township 4 South, Range 1 East of Humboldt Meridian and particularly described as follows:

BEGINNING at the Quarter Section corner set by Licensed Surveyor F.A. McKee at the center of said Section 1; and running  
thence East along the Quarter Section line 626.13 feet;  
thence North parallel with the Quarter Section line running North and South through the center of said Section 1, a distance of 417.42 feet;  
thence West parallel with the Quarter Section line running East and West through the center of said Section 1, a distance of 626.13 feet to the aforementioned North and South Quarter Section line;  
thence South along the last mentioned line 417.42 feet to the point of beginning.
