RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE HUMBOLDT COUNTY DISTRICT ATTORNEY'S OFFICE TO APPLY FOR, ACCEPT AND ADMINISTER FUNDING MADE AVAILABLE BY THE CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES THROUGH THE VICTIM WITNESS ASSISTANCE PROGRAM

WHEREAS, the County of Humboldt ("County"), by and through the Humboldt County District Attorney's Office – Victim Witness Unit, is required to provide comprehensive services to victims and witnesses of all types of violent crime, pursuant to California Penal Code Section 13835; and

WHEREAS, County, by and through the Humboldt County District Attorney's Office – Victim Witness Unit, desires to undertake a project designated as the Victim Witness Assistance Program to be funded in part from funds made available by the California Governor's Office of Emergency Services ("Cal OES").

## NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The Humboldt County District Attorney's Office is hereby authorized and directed to apply for, accept and administer funding made available by Cal OES through the Victim Witness Assistance Program.
- 2. The Humboldt County District Attorney and the Humboldt County Auditor-Controller, or a designees thereof, are hereby authorized to execute any and all certifications, agreements, amendments and other documents required, or deemed necessary or appropriate, to apply for, accept and administer funding made available by Cal OES through the Victim Witness Assistance Program.
- 3. The County hereby represents and certifies that all Victim Witness Assistance Program funding awarded to the Humboldt County District Attorney's Office will be used in a manner consistent, and in compliance, with any and all applicable local, state and federal laws, regulations, requirements and standards, as well as any and all applicable agreements between the County and Cal OES.
- 4. The County hereby represents and certifies that the Victim Witness Assistance Program funding awarded to the Humboldt County District Attorney's Office will not be used to supplant expenditures controlled thereby.
