Termination of Local Emergency – Prolonged Drought in Humboldt County

<u>RECOMMENDATION(S)</u>: That the Board of Supervisors terminates the local emergency, per the attached Resolution # $\frac{10 - 10}{10}$ related to prolonged drought in Humboldt County.

<u>DISCUSSION</u>: On July 15, 2014 the Board of Supervisors ratified the Humboldt County Sheriff's declaration of the existence of a Local Emergency because of the conditions of extreme peril to safety of persons and property within the county caused by prolonged drought.

Since July, 2014, the Humboldt County Sheriff – Office of Emergency Services (OES) has been monitoring drought conditions within the county to determine if the conditions of extreme peril warrant and necessitate the continuation of the local emergency.

At this time, the Sheriff has determined that the emergency no long exists and that the attached Resolution should be adopted to terminate the local emergency.
