Subject: ADOPTION OF ORDINANCE: ADDING SECTIONS 414- 3 AND 414-4 RELATING TO LENGTH AND WIDTH RESTRICTIONS ON SOUTH DOBBYN CREEK BRIDGE ON ZENIA BLUFF ROAD TO TITLE IV OF THE HUMBOLDT COUNTY CODE

RECOMMENDATION(S): That the Board of Supervisors adopt Ordinance No. 2552, Adding Sections 414-3 and 414-4 relating to length and width restrictions on South Dobbyn Creek Bridge on Zenia Bluff Road to Title IV of the Humboldt County Code

SOURCE OF FUNDING: Road Fund (1200325)

DISCUSSION: On June 7, 2016, the Board of Supervisors introduced the above ordinance for adoption; with a directive to the Clerk of the Board to publish a pre-adoption summary of the ordinance and set the ordinance for adoption at least one week away. This action completes adoption of the ordinance and will result in publication of a post-adoption summary.

FINANCIAL IMPACT: The cost for the manufacturing and installation of the regulatory signs is covered in the Road Fund budget. There will be no impact to the General Fund.

**ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT
ADDING SECTIONS 414-3 AND 414-4 RELATING TO LENGTH AND WIDTH
RESTRICTIONS ON SOUTH DOBBYN CREEK BRIDGE ON ZENIA BLUFF ROAD TO
TITLE IV OF THE HUMBOLDT COUNTY CODE**

ORDINANCE NO. 2552

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1. Sections 414-3 and 414-4 of Chapter 4 of Division 1 of Title IV of the Humboldt County Code are added as shown on the attached pages.

SECTION 2. This ordinance shall take effect and be in force thirty (30) days from the date of its passage. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of Humboldt, State of California.

CHAPTER 4

LENGTH AND WIDTH RESTRICTIONS**414-1. LENGTH AND WIDTH RESTRICTIONS ON A PORTION OF DAVISON ROAD.**

Pursuant to § 21101(c) of the Vehicle Code of the State of California, no vehicle or combination of vehicles having a body width greater than eight feet (8') and a body length greater than twenty-four feet (24'), except road maintenance vehicles and emergency vehicles, shall be allowed to use the following described portion of Davison Road (County Road No. 4R400) in the Orick area: 9Ord. (Ord. 1858, § 1, 3/28/89)

That portion of Davison Road (County Road No. 4R400) from a point 0.37 miles (0.60 kilometers) west of State Highway 101 to its terminus, 3.65 miles (5.87 kilometers) west of State Highway 101. (Ord. 832, § 1, 3/14/72)

414-2. PENALTY.

It shall be unlawful and an infraction for any person to drive a vehicle upon the portion of Davison Road (County Road No. 4R400) referred to in § 414-1 of this chapter in violation of the length and width limitations prescribed therein. Every person convicted of such infraction shall be punished upon first conviction by a fine not exceeding Fifty Dollars (\$50.00), and for a second conviction within a period of one (1) year by a fine not exceeding One Hundred Dollars (\$100.00), and for a third or any subsequent conviction within said period of one (1) year by a fine not exceeding Two Hundred Fifty Dollars (\$250.00). 414-3. LENGTH AND WIDTH RESTRICTION ON SOUTH DOBBYN CREEK BRIDGE ON ZENIA BLUFF ROAD.

Pursuant to § 21101(c) of the Vehicle Code of the State of California, no vehicle or combination of vehicles having a body width greater than eight feet (8') and a body length greater than thirty-two feet (32') kingpin to rear axle, except road maintenance vehicles and emergency vehicles, shall be allowed to use the South Dobbyn Creek Bridge (County Bridge No. 04C0064) on Zenia Bluff Road (County Road No. F8C090). (Ord. __, § __, __/__/2016)

414-4. PENALTY.

It shall be unlawful and a misdemeanor for any person to drive a vehicle across South Dobbyn Creek Bridge (County Bridge No. 04C0064) referred to in § 414-3 of this chapter in violation of the length and width limitations prescribed therein. Every person convicted of such misdemeanor shall be punished by a fine not exceeding One Thousand Dollars (\$1,000.00) and/or imprisonment for a term not exceeding six (6) months, or by both such fine and imprisonment.
