Exception to the 180-day wait period Government Code Sections 7522.56 And 21224

WHEREAS, in compliance with Government Code section 7522.56 the Humboldt County Board of Supervisors must provide California Public Employees Retirement System (CalPERS) this certification resolution when hiring a retiree before 180 days has passed since his retirement; and

WHEREAS, Dennis Griffin retired from the Sheriff's Department of the County of Humboldt in the position as Correctional Lieutenant, effective December 5, 2025; and

WHEREAS, Section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is June 3, 2026, without this certification resolution; and

WHEREAS, Section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, the Humboldt County Board of Supervisors, the Sheriff's Department, the County of Humboldt and Dennis Griffin certify that Dennis Griffin has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, the Humboldt County Board of Supervisors hereby appoints Dennis Griffin as an extra help retired annuitant to perform the duties of an Administrative Analyst II for the Sheriff's Department of the County of Humboldt under Government Code section 21224, effective January 18, 2026; and

WHEREAS, the entire employment agreement, contract or appointment document between Dennis Griffin and the Sheriff's Department of the County of Humboldt has been reviewed by this body and is included herein; and

WHEREAS, no matters, issues, terms or conditions related to this employment appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be a limited duration appointment to a temporary position and will be limited to 960 hours per fiscal year; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum annual base salary paid to other employees performing comparable duties, divided by 2080 to equal an hourly rate; and

WHEREAS, the maximum base annual salary for this position is \$73,756.80 and the hourly equivalent is \$35.46, and the minimum base annual salary for this position is \$57,470.40 and the hourly equivalent is \$27.63; and

WHEREAS, the hourly rate paid to Dennis Griffin will be \$35.46; and


WHEREAS, Dennis Griffin has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors hereby certifies the nature of the appointment of Dennis Griffin as described herein and detailed in the attached agenda item titled "Temporary Employment of Retired Annuitant as Administrative Analyst II in the Sheriff's Department of the County of Humboldt", is necessary to fill the critically needed position of Administrative Analyst II by January 18, 2026 because Dennis Griffin has unique knowledge and skills related to the Sheriff's Department Background Division's administrative duties and will be able to provide much needed support to the Sheriff's Department of the County of Humboldt.
