**AMENDING SECTION 311-7 OF THE HUMBOLDT COUNTY CODE
BY REZONING PROPERTY IN THE KORBEL AREA
[PLN-2021-16919 (BLANC)]**

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1. ZONE AMENDMENT. Section 311-7 of the Humboldt County Code is hereby amended by reclassifying the property described in the Attached Exhibit A as follows: approximately 6.2 acres of Agriculture Exclusive with a 160-acre minimum parcel size (AE-B-5(160)) into Timberland Production Zone (TPZ) and approximately 3.09 acres of TPZ into AE-B-5(160).

The area described is also shown on the Humboldt County Zoning Maps [Q-23 and R-23] and on the map attached as Exhibit B.

SECTION 2. EFFECTIVE DATE. This ordinance shall become effective thirty (30) days after the date of its passage.

Area to be taken out of Agriculture and placed into Timber Production Zone within R.H. Emmerson parcel, 316-206-002 is described as follows:

That portion of the Southeast quarter of the Northwest quarter of Section 19, Township 5 North, Range 4 East, Humboldt Meridian, lying north of the following line:

Beginning at the Center West sixteenth corner as per Book 60 of Surveys, Page 55, Humboldt County Records (HCR):

Thence along the subdivision line, North 00 degrees 58 minutes 09 seconds East, 225.28 feet,


Thence along the southerly line of the south parcel depicted in 50R/S75, North 65 degrees 37 minutes 25 seconds East, 149.41 feet,

Thence along the easterly line of parcels depicted in 50 R/S 75, North 00 degrees 42 minutes 23 seconds East, 438.29 feet to the POINT OF BEGINNING,

Thence East, 287.28 feet,

Thence Northeasterly to the Timber Production Zone line of the area that extends in a southeasterly direction in the north portion of the Southeast Quarter of the Northwest Quarter of said Section 19, as shown on the Humboldt County Zone Maps.

Area to be placed into Timber Production Zone within Sierra Pacific parcel, 316-206-009 is described as follows:

That portion of Lot 2 of Section 19, Township 5 North, Range 4 East, Humboldt Meridian described as follows;

Beginning at the Northwest corner of said Lot 2,

Thence along the westerly line of said Lot 2, South 00 degrees 42 minutes 21 seconds West, 440 feet,

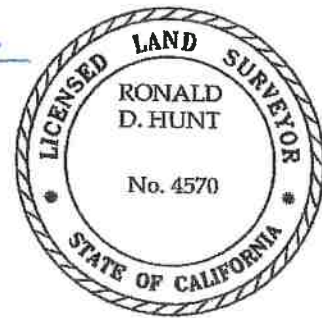
