Supplemental Budget to Install Data Cable System at Clark Complex (requires 4/5 vote)

RECOMMENDATION(S):

That the Board of Supervisors approve the attached supplemental budget in the amount of \$41,500 for costs associated with installing an upgraded data cable system at the Clark Complex (requires 4/5 vote).

SOURCE OF FUNDING:

General Fund

DISCUSSION:

As part of the adoption of the fiscal year 2015-16 budget additional funding was allocated to upgrade outdated wiring in the Clark Complex in order to replace the failing phone system that serves Planning and Building and the Public Works-Land Use division. Due to unanticipated conditions that were encountered in the facility the project was not able to be done last fiscal year. The funding was not spent and needs to be carried over into the current fiscal year so the project can be completed. Staff is trying to expedite this project because the phone system is failing which has resulted in service outages.

It is recommended that the Board approve the attached supplemental budget for Current Planning in the amount of \$41,500. Due to the urgency of this project this budget adjustment is being done now rather than as part of the First Quarter Budget Review.

FINANCIAL IMPACT:

The approval of the supplemental budget will carry over \$41,500 in fund balance from the General Fund for FY 2016-17 expenditure. These funds were allocated last fiscal year and not spent which resulted in the monies being added to the year end fund balance.
