RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING APPLICATION FOR, AND ACCEPTANCE OF, FUNDING MADE AVAILABLE THROUGH THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT'S TRANSITIONAL HOUSING PROGRAM AND HOUSING NAVIGATION AND MAINTENANCE PROGRAM

WHEREAS, the State of California, by and through its Department of Housing and Community Development ("Department"), issued an Allocation Acceptance Form, dated October 19, 2023 under Round Five of the Transitional Housing Program ("THP"), authorized by item 2240-102-0001 of Section 2.00 of the Budget Act of 2023 (Chapter 12 of the Statutes of 2023) and Chapter 11.7 (commencing with Section 50807) of part 2 of Division 31 of the California Health and Safety Code ("THP Allocation Acceptance Form"); and

WHEREAS, the Department issued an Allocation Acceptance Form, dated October 19, 2023 under Round Two of the Housing Navigation and Maintenance Program ("HNMP") authorized by Item 2240-103-0001 of Section 2.00 of the Budget Act of 2023 (Chapter 12 of the Statutes of 2023) and Chapter 11.8 (commencing with Section 50811) of Part 2 of Division 31 of the California Health and Safety Code ("HNMP Allocation Acceptance Form"); and

**WHEREAS,** The THP Allocation Acceptance Form and the HNMP Allocation Acceptance Form are collectively referred to as the "Allocation Acceptance Forms;" and

**WHEREAS**, the Allocation Acceptance Forms relate to the availability of the funds under the THP and HNMP Programs; and

**WHEREAS**, the County of Humboldt ("County") was listed as an eligible applicant in the Allocation Acceptance Forms, dated October 19, 2023; and

**WHEREAS**, the County has received an allocation of THP funding in the amount of Two Hundred Nineteen Thousand Seven Hundred Eighty Dollars (\$219,780.00); and

**WHEREAS**, the County has received an allocation of HNMP funding in the amount of One Hundred Ten Thousand Five Hundred Forty-Five Dollars (\$110,545.00).

## NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. That County is hereby authorized and directed to apply for and accept County's allocation award, as detailed in the THP Allocation Acceptance Form ("THP Allocation Award"), up to the amount authorized in the THP Allocation Acceptance Form and applicable state law.
- 2. That County hereby affirms that if THP funds remain available for allocation after the deadline for submitting a signed THP Allocation Acceptance Form, and if Department advises County that it is eligible for an additional allocation from these remaining funds, County is hereby authorized and directed to accept this additional allocation of funds ("Additional THP Allocation") up to the amount authorized by Department.

- **3.** That County is hereby authorized and directed to apply for and accept County's allocation award, as detailed in the HNMP Allocation Acceptance Form ("HNMP Allocation Award"), up to the amount authorized in the HNMP Allocation Acceptance Form and applicable state law.
- 4. That County hereby affirms that if HNMP funds remain available for allocation after the deadline for submitting a signed HNMP Allocation Acceptance Form, and if Department advises County that it is eligible for an additional allocation from these remaining funds, County is hereby authorized and directed to accept this additional allocation of funds ("Additional HNMP Allocation") up to the amount authorized by Department.
- 5. That the Humboldt County Department of Health and Human Services Director ("Director"), or a designee thereof, is hereby authorized and directed to act on behalf of County in connection with the THP Allocation Award and any Additional THP Allocation, and to enter into, execute, and deliver any and all documents required or deemed necessary or appropriate to participate in the THP, including, but not limited to a State of California Standard Agreement, and accept the THP Allocation Award, and any Additional THP Allocation, and any amendments to such documents (collectively referred to as, "THP Allocation Award Documents").
- 6. That the Director, or a designee thereof, is hereby authorized and directed to act on behalf of County in connection with the HNMP Allocation Award and any Additional HNMP Allocation, and to enter into, execute, and deliver any and all documents required or deemed necessary or appropriate to participate in the HNMP, including, but not limited to a State of California Standard Agreement, and accept the HNMP Allocation Award, and any Additional HNMP Allocation, and any amendments to such documents (collectively referred to as, "HNMP Allocation Award Documents").
- 7. That County shall be subject to the terms and conditions that are specified in the THP and HNMP Allocation Award Documents, and that County will use the THP and HNMP Allocation Award funds, and any Additional THP and HNMP Allocation funds, in accordance with the Allocation Acceptance Forms, the THP and HNMP Allocation Award Documents and any and all other THP and HNMP requirements or other applicable laws.
