**RESOLUTION SUPPORTING THE DEVELOPMENT OF AND DESIGNATING  
CERTAIN COUNTY ROADS AS PART OF UNITED STATES BIKE ROUTE 95**

**WHEREAS**, bicycle tourism is a growing industry in North America, contributing \$47 billion annually to the economies of communities that provide facilities for such tourists; and

**WHEREAS**, the American Association of State Highway and Transportation Officials (AASHTO) has designated a corridor crossing California to be developed as United States Bike Route 95 (USBR 95); and

**WHEREAS**, the Adventure Cycling Association and the California Bicycle Coalition, with the cooperation of Caltrans, have proposed a specific route to be designated as USBR 95; and

**WHEREAS**, the proposed USBR 95 will provide a further prominent and nationwide designation for bicycle travel through Humboldt County; and

**WHEREAS**, the proposed route for USBR 95 comes through Humboldt County and can therefore provide benefits to our residents and businesses; and

**WHEREAS**, the County of Humboldt seeks to ensure a safe and efficient use of the road network by cyclists; and

**WHEREAS**, the Department of Public Works has investigated the proposed route consisting of roads listed in Exhibit A, and found it to be a suitable route, and desire that the route be designated so that it can be mapped and signed, thereby promoting bicycle tourism in our area; and

**WHEREAS**, the Board of Supervisors endorses the USBR 95 route designation as a collaborative endeavor in support of cycling.

**NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:**

1. Humboldt County hereby expresses its approval and support for the development of USBR 95; and
2. Requests Caltrans get the route officially designated by AASHTO as soon as this can be achieved; and
3. Authorizes the posting of signs within the Humboldt County right-of-way identifying the route through the community once the official designation has been made; and
