DISCUSSION:

The request before you today is to correct a clerical oversight by approving the allocation of 1.0 FTE Office Assistant I/II (class 180, Range 255/286) in Cannabis Planning budget unit 268, effective July 1, 2017 and an appropriation transfer to move the funds budgeted for this position in Building Inspector budget unit 262 to Cannabis Planning budget unit 268. During the fiscal year 2017-18 budget adoption process, this position was inadvertently not included in the Personnel Allocation Table and the funding was allocated to the incorrect budget unit due to departmental restructuring.

FINANCIAL IMPACT:

Salaries associated to this position have been included in the Building Inspector budget unit 262 in the fiscal year 2017-18 budget. It had been the intention of the department to budget for this position in the Cannabis Planning budget unit 268 however that was not completed through budget adoption as intended. An appropriation transfer (Attachment I) will effectuate the transfer of salary expenses for 1.0 FTE Office Assistant I/II budgeted in Building Inspector budget unit 262 to Cannabis Planning budget unit totaling \$44,462.

This request meets your Board's Strategic Framework of Priorities for New Initiatives by providing the community appropriate levels of service and managing resources to ensure sustainability of services.
