C. WHO IS AN INSURED

- (a) In the performance of your ongoing operations;

 - (i) The written contract or written agreement requires you to provide such coverage to such additional insured; and
 - (ii) This Coverage Part provides coverage for "bodily injury" or "property damage" included within the "products-completed operations hazard.

E.5. Separation of Insureds
