

ORDINANCE AMENDING SECTION 314-6 AND 314-7 OF THE HUMBOLDT COUNTY CODE
 BY REZONING PROPERTY IN THE EUREKA AREA
 [PLN-2025-19448 (Green Diamond Resource Company Rezone)]

ORDINANCE NO. _____

The Board of Supervisors of the County of Humboldt do ordain as follows:

SECTION 1. ZONE AMENDMENT. Section 314-6 and 314-7 of the Humboldt County Code is hereby amended by reclassifying 65 acres on APN 303-012-022-000 in the Eureka area from Timberland Production (TPZ) to Qualified Agriculture Exclusive (AE-Q), and 33.5 acres on APN 303-012-022-000 from Agriculture General with a Special Building Site combining zone (AG-B-5(5)) to Residential One-Family (R-1).

The area described is shown on the Zoning Map for the Eureka Community Plan and on the map attached as Exhibit A.

SECTION 2. ZONE QUALIFICATION. The principally permitted uses and uses permitted with a use permit set forth in the Agriculture Exclusive (AE) zone are modified as shown in Section 4 in accordance with Humboldt County Code Section 314-32, which authorizes restriction of the AE zone regulations by application of the “Q” (Qualified Combining Zone).

SECTION 3. PURPOSE OF QUALIFICATIONS. The purpose of the special restrictions and regulations herein imposed on the properties described in Section 1 are:

(a) To restrict the use of the Agriculture Exclusive zone to those consistent with the Open Space land use designation.

SECTION 4. SPECIAL RESTRICTIONS. Principal permitted uses and uses permitted with a use permit otherwise allowed under the AE zone regulations of Humboldt County Code Section 314-7.1 are revised as follows:

AE: Agriculture Exclusive
