**RESOLUTION TO ACCEPT THE RIGHTS OF WAY FOR WASHINGTON COURT AND ASCENT PLACE
FOR PUBLIC ROAD PURPOSES AND FOR PUBLIC SIDEWALK EASEMENT PURPOSES**

WHEREAS, Section 66477.2 of the Government Code authorizes the Board of Supervisors by resolution to rescind its action and accept the offer of dedication on a map and open the streets, paths and alleys, and right-of-way easements to the public; and

WHEREAS, an offer of dedication to the County of Humboldt of Washington Court and Ascent Place for public road purposes and for Parcel D for pedestrian easement and for Parcels A, B & C in Fee Title for Drainage Facility Purposes was made on Tract Map No. 0676 by JLF Construction, Inc.; and

WHEREAS, On December 19, 2023, the Humboldt County Board of Supervisors did not accept the offer of said dedication; of Washington Court for public road purposes; Ascent Place for public road purposes; Parcel D for pedestrian easement; Parcels A, B & C in fee title for drainage facility purposes; and

WHEREAS, On December 26, 2023, Tract Map No. 0676 was filed in Book 26 of Maps, pages 18, 19, 20, 21 in the office of the Humboldt County Recorder and is incorporated herein by reference; and

WHEREAS, County now desires to accept the dedication of; Washington Court for public road purposes and for public sidewalk easement purposes; Ascent Place for public road purposes and for public sidewalk easement purposes; Parcel D for pedestrian easement; Parcels A, B & C in fee title for drainage facility purposes; and

WHEREAS, Sidewalks within and fronting the subdivision will not be maintained by the County. Pursuant to Resolution 21-39, adopted by the Board of Supervisors on April 20, 2021, maintenance of sidewalks is the responsibility of the fronting landowner.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED

1. Humboldt County Board of Supervisors rescinds its December 19, 2023, action of not accepting the dedication and hereby accepts the dedication of; Washington Court for public road purposes and for public sidewalk easement purposes; Ascent Place for public road purposes and for public sidewalk easement purposes; Parcel D for pedestrian easement; Parcels
