1. On May 7, 2020 the Humboldt County Planning Commission APPROVED the Humboldt County Department of Public Works Coastal Development Permit Case Number PLN-2019-15881.
2. The Humboldt County Department of Public Works withdrew this Application on May 20, 2020. The reason given for the withdrawal was, "Public Works has re evaluated its approach for environmental review under CEQA for this and other projects involving existing facilities. In order to ensure a thorough review of potentially significant environmental impacts, Public Works hereby withdraws its permit application in order to perform additional environmental review under CEQA."
3. A thorough review of PLN-2019-15881 would have included a review of the Public Comments submitted with that application.
4. The package for Humboldt County Department of Public Works Coastal Development Permit Case Number PLN-2021-17402 did not include The Public Comments included in the application for PLN-2019-15881.
