RESOLUTION 2016-2017-01

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE REDWAY COMMUNITY SERVICES DISTRICT

REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT TO RENDER SPECIFIED SERVICES TO THE DISTRICT RELATING TO THE CONDUCT OF A DISTRICT ELECTION TO BE HELD MAY 2^{NO}, 2017

Whereas, a District Election is to be held in the Redway Community Service District (RCSD) Area of Service on May 2nd 2017, and

Whereas, in the course of conduct of the election it is necessary for the RCSD to request services of the County, and

Whereas, all necessary expenses in performing these services shall be paid by the RCSD.

Now, therefore, the board of the RCSD does resolve, declare, determine and order as follows.

- That the Redway Community Services District requests and consents to consolidation of this election with other elections which may be held on May 2nd, 2017, in whole or in part of the territory of the district, pursuant to Elections Code 10403.
- That the County of Humboldt Registrar of Voters is authorized to canvass the returns of the District election. The election shall be held in all respects as if there were only one election, and only one form of ballot shall be used. If acceptable to the Humboldt County Elections Office, mail in ballot protocol will be utilized for the election.
- That the Board of Supervisors is requested to issue instructions to the Humboldt County registrar of voters take any and all steps necessary for the holding of the consolidated election.
- That the Redway Community Services District recognizes that additional costs will be incurred by the County of Humboldt by reason of this consolidation and agrees to reimburse the County for any costs.
- That the Redway Community Services District acknowledges that the consolidated election will be held and conducted in the manner prescribed in Elections Code section 10418.
- 6. That RCSD Staff is directed to forward without delay to the board of supervisors and to the County
- 7. Election Department each a certified copy of this Resolution.
