SUBJECT:

Grant Agreement between California Department of Public Health, Office of AIDS and the Public Health Communicable Disease Program for HIV/AIDS Surveillance in the Amount of \$56,415

RECOMMENDATION(S):

That the Board of Supervisors:

- 1. Approve Grant Agreement # 24-10279 with California Department of Public Health (CDPH), Office of AIDS in the amount of \$56,415 for the period of July 1, 2024, through June 30, 2029;
- 2. Authorize the Director of Public Health, or designee to electronically sign grant agreement # 24-10279, Contractor Certification Clause (CCC 04/2017) and of the Civil Rights Form; and
- 3. Authorize the Director of Public Health, or designee, to sign any subsequent amendments or documents directly related to Grant Agreement # 24-10279 upon County Counsel, Risk Management, and County Administrative Office (CAO) review and approval.

STRATEGIC PLAN:

DISCUSSION:

California Department of Public Health (CDPH)'s Office of AIDS has contracted with DHHS - Public Health since the late 1980's to provide HIV/AIDS services in Humboldt County. The goal of the HIV/AIDS Surveillance Program is to establish and enhance active and passive HIV/AIDS case surveillance in health and social service settings. Goals include improving the timeliness, accuracy and reliability of local HIV/AIDS case data; investigating reported HIV/AIDS cases in order to establish an accurate mode of HIV transmission; and in conjunction with CDPH, Office of AIDS staff, conducting investigations of cases that are of public health importance.

Grant Agreement # 24-10279 before your Board today will allow DHHS - Public Health to be reimbursed for a maximum of \$56,415 for surveillance activities performed within the period beginning July 1, 2024, through June 30, 2029.

Narrative Explanation of Financial Impact:

Approval of grant 24-10279 in the amount of \$56,415 with the California Department of Public Health (CDPH) California HIV Surveillance Program allows the County of Humboldt Department of Health and Human Services Public Health to be reimbursed a maximum amount of \$11,283 annually for fiscal years 2024-25 through 2028-29. The annual reimbursement will be used by Public Health Fund 1175, Budget Unit 419. This was anticipated in the fiscal year 2024-25 budget, and no supplemental budget is required.

STAFFING IMPACT:

Acceptance of this grant will help maintain current staffing levels by providing partial funding for a Public Health Nurse.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could choose not to approve the agreement from CDPH, however it is not recommended as DHHS - Public Health would not be reimbursed for the HIV/AIDS Surveillance Program if state funds are not accepted.
