RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS RECOGNIZING THE DEPARTMENT OF HEALTH AND HUMAN SERVICES – PUBLIC HEALTH LABORATORY IN REGARD TO THE INVESTIGATION OF A BIOTERRORISM EVENT AT PELICAN BAY STATE PRISON

WHEREAS, the Humboldt County Department of Health & Human Services Public Health Laboratory provides a wide range of laboratory services daily that protect and support the health of Humboldt County residents; and

WHEREAS, the Public Health Lab provides expansive environmental services such as drinking water analysis, water testing for public events and local state parks, and testing of local oyster and shellfish growing waters for our local oyster businesses, as well as rabies and tick testing; and

WHEREAS, the Lab's clinical services provide testing for influenza, measles, norovirus and many other communicable diseases for local health care providers to identify and help prevent or stop outbreaks within the community; and

WHEREAS, the Public Health Lab's BSL-3 bioterrorism lab is actively part of the Centers for Disease Control and Prevention (CDC's) nationwide Laboratory Response Network which assists in protecting the nation from biological bioterrorism threats and is a local lab focusing specifically on threats in Humboldt, Del Norte and parts of Trinity counties; and

WHEREAS, Lab staff, working with staff from the CDC, Federal Bureau of Investigation, California Department of Public Health, Del Norte County and numerous other agencies, were instrumental in the investigation of a bioterrorism event at Pelican Bay State Prison in Del Norte County; and

WHEREAS, Lab staff professionally and promptly identified a suspicious substance which tested positive as the neurotoxin ricin; and

WHEREAS, the CDC's Laboratory Response Network has recognized the Public Health Lab's efforts during the Pelican Bay State Prison event via a letter and certificate; and

WHEREAS, Lab staff are experts in laboratory sciences and use their skills and dedication to help protect the local community with professionalism on a daily basis; and

WHEREAS, the Humboldt County Public Health Laboratory is an important asset to the residents of Humboldt, Del Norte, and parts of Trinity counties.
