RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT INCREASING REVOLVING FUND FOR USE OF COUNTY CLERK / RECORDER AND RESCINDING RESOLUTIONS NO. 88-108 AND RESOLUTION NO. 93-93

WHEREAS, Section 29320, et seq. of the Government Code of California authorizes the Board of Supervisors to establish revolving funds for the use of any officer of the County; and

WHEREAS, there has previously been established two revolving funds in the amount of \$225.00 for the County Clerk Department and \$50.00 for the Recorder Department; and

WHEREAS, the County Clerk / Recorder Department has requested a rescission of the previous two revolving fund resolutions No. 88-108 and 93-93 in the total amount of \$275.00; and

WHEREAS, the County Clerk / Recorder has requested a newly established revolving fund in the amount of \$1,500.00; and

WHEREAS, the revolving fund is necessary for daily operations of making change for cash transactions;

NOW, THEREFORE, BE IT RESOLVED that the County of Humboldt Board of Supervisors hereby rescinds Resolution No. 88-108 and Resolution No. 93-93, previously adopted by the Board of Supervisors.


BE IT FURTHER RESOLVED that the County Board of Supervisors hereby establishes a revolving fund for the use of the County Clerk / Recorder in the amount of \$1,500.00 subject to the provisions of Section 29320 et seq. of the Government Code.

BE IT FURTHER RESOLVED that the Clerk of the Board of Supervisors shall transmit certified copies of the resolution to the Auditor-Controller and the Treasurer for the County of Humboldt pursuant to Government Code 29322.


