

**FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT  
BETWEEN THE COUNTY OF HUMBOLDT AND  
PLANET LABS, INC.**

This amendment, entered into this \_\_\_\_ day of \_\_\_\_\_, 2020, is the second amendment to the Professional Services Agreement executed on April 17, 2018, between the County of Humboldt, a political subdivision of the State of California (“COUNTY”), and Planet Labs Inc., a Delaware corporation (“C”), for the purpose of providing high resolution satellite images with periodic and regular updates.

WHEREAS, County has retained the services of a qualified firm to provide high resolution satellite images; and

WHEREAS, County has a regular and ongoing need to review and verify cannabis cultivation and development in rural areas via satellite imagery; and

WHEREAS, the original High Resolution Imagery Professional Services Agreement signed on April 17, 2018 and amended on January 9, 2019 expires December 30, 2020; and

WHEREAS, the satellite imagery services provided by the Contractor continues to be needed and both parties wish to extend the Agreement.

NOW THEREFORE, the Parties hereto mutually agree to the following:

Section 2. TERM is hereby deleted in its entirety and replaced with the following:

“This Agreement shall begin on April 11, 2018 and shall remain in full force and effect until December 31, 2023, unless extended by mutual agreement of the parties or terminated sooner as provided herein.”

Section 4. COMPENSATION is hereby deleted in its entirety and replaced with the following:

“Maximum amount payable. The maximum amount payable by COUNTY for the licenses and services provided, and costs and expenses incurred, pursuant to the terms and conditions of this Agreement is Two Hundred Ninety Six Thousand Six Hundred Ninety Six Dollars and Forty Nine Cents (\$296,696.49) per year. Total cost for the agreement term: USD \$890,089.47.

EXHIBIT A

Exhibit A representing Order Schedule PL-017832 is hereby deleted in its entirety and replaced with Exhibit A representing Opportunity ID PL-0021627 reflecting an order schedule for the three (3) year period of this amendment.

In all other respects the Professional Services Agreement dated April 13, 2018, between the parties shall remain in full force and effect.
