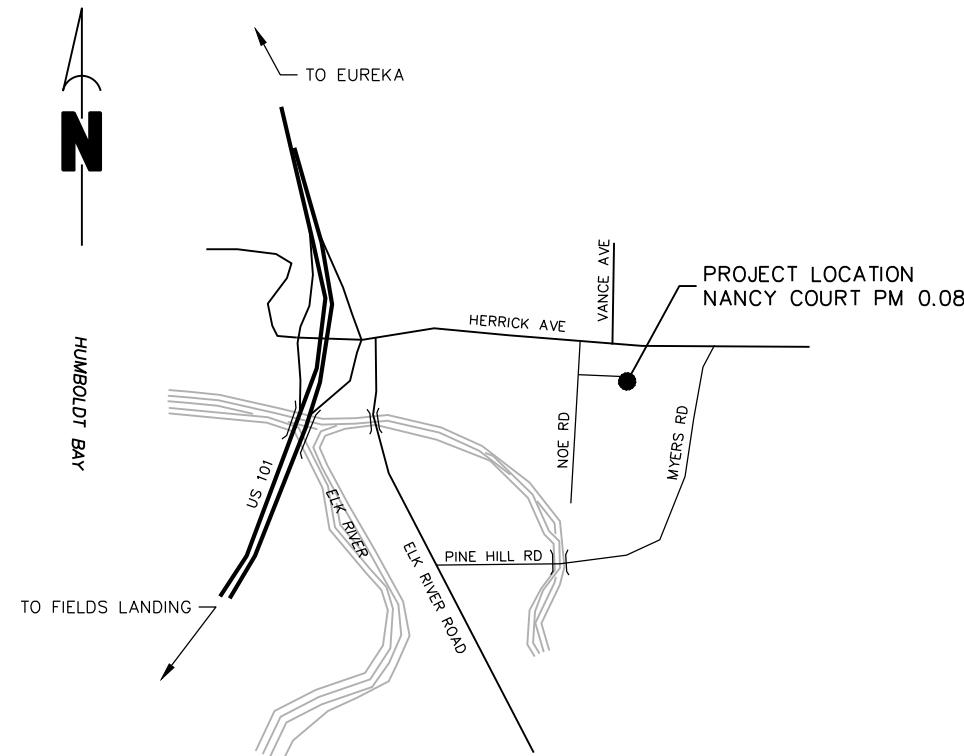

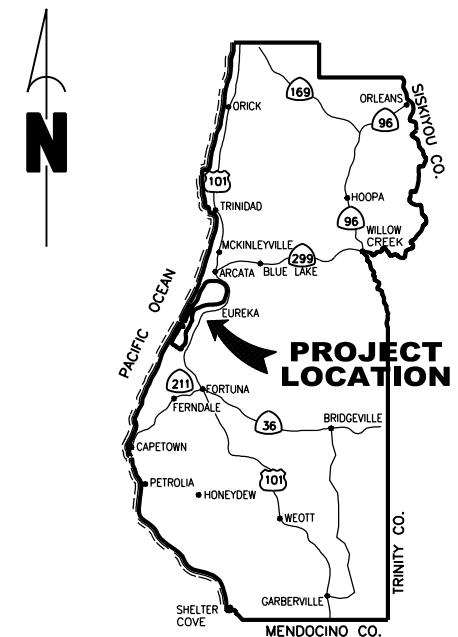

- 2) IF MONUMENT IS DAMAGED BY CONTRACTORS OPERATIONS, CONTRACTOR SHALL REPLACE MONUMENT AT CONTRACTORS EXPENSE.
- 3) UNDERGROUND UTILITIES ARE PRESENT IN THE JOB SITE. CALL UNDERGROUND SERVICE ALERT (USA) 1-800-642-2444 OR CALL 811 A MINIMUM OF 48 HOURS PRIOR TO ANY EXCAVATIONS.
- 4) MANAGE MATERIAL PER SECTION 13-4.03C OF THE CURRENT CALTRANS STANDARD SPECIFICATIONS.
- 5) IF STOCKPILE AREA IS IN A TURNOUT, THE TURNOUT SHALL BE REESTABLISHED TO PRE-CONSTRUCTION CONDITIONS.

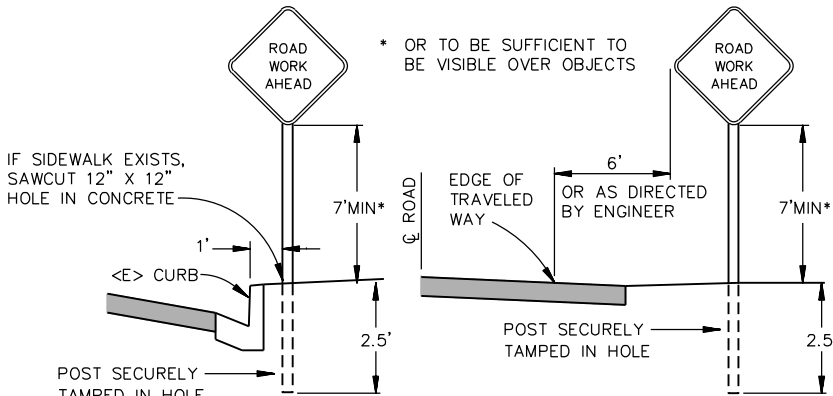

SIGN NOTES

- 1) SIGNS SHALL BE PLACED AS SHOWN ON PLAN OR AS DIRECTED BY THE ENGINEER.
- 2) PORTABLE SIGNS MAY BE USED INSTEAD OF TEMPORARY SIGNS. ADDITIONAL PORTABLE SIGNS MAY BE REQUIRED FOR OTHER ROADSIDE WORK.
- 3) SEE CALTRANS STANDARD PLAN DETAIL T13 - TRAFFIC CONTROL SYSTEM FOR ONE-LANE CLOSURE.
- 4) THE CONTRACTOR SHALL UTILIZE FLAGMEN AS NECESSARY TO DIRECT TRAFFIC.
- 5) KEEP A MINIMUM OF 1 TRAFFIC LANE AT LEAST 10' WIDE OPEN FOR TRAFFIC, EXCEPT THE FULL WIDTH OF THE TRAVELED WAY MUST BE OPEN WHEN CONSTRUCTION OPERATIONS ARE NOT ACTIVE OR AN APPROVED TRAFFIC CONTROL PLAN IS IN PLACE
- 6) NOTIFY LANDOWNERS 2 DAYS IN ADVANCE FOR DRIVEWAY CLOSURE

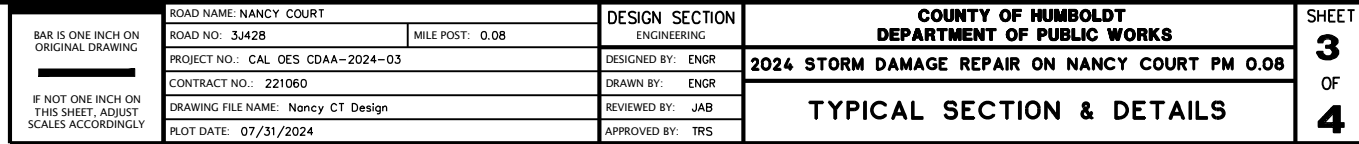

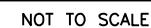

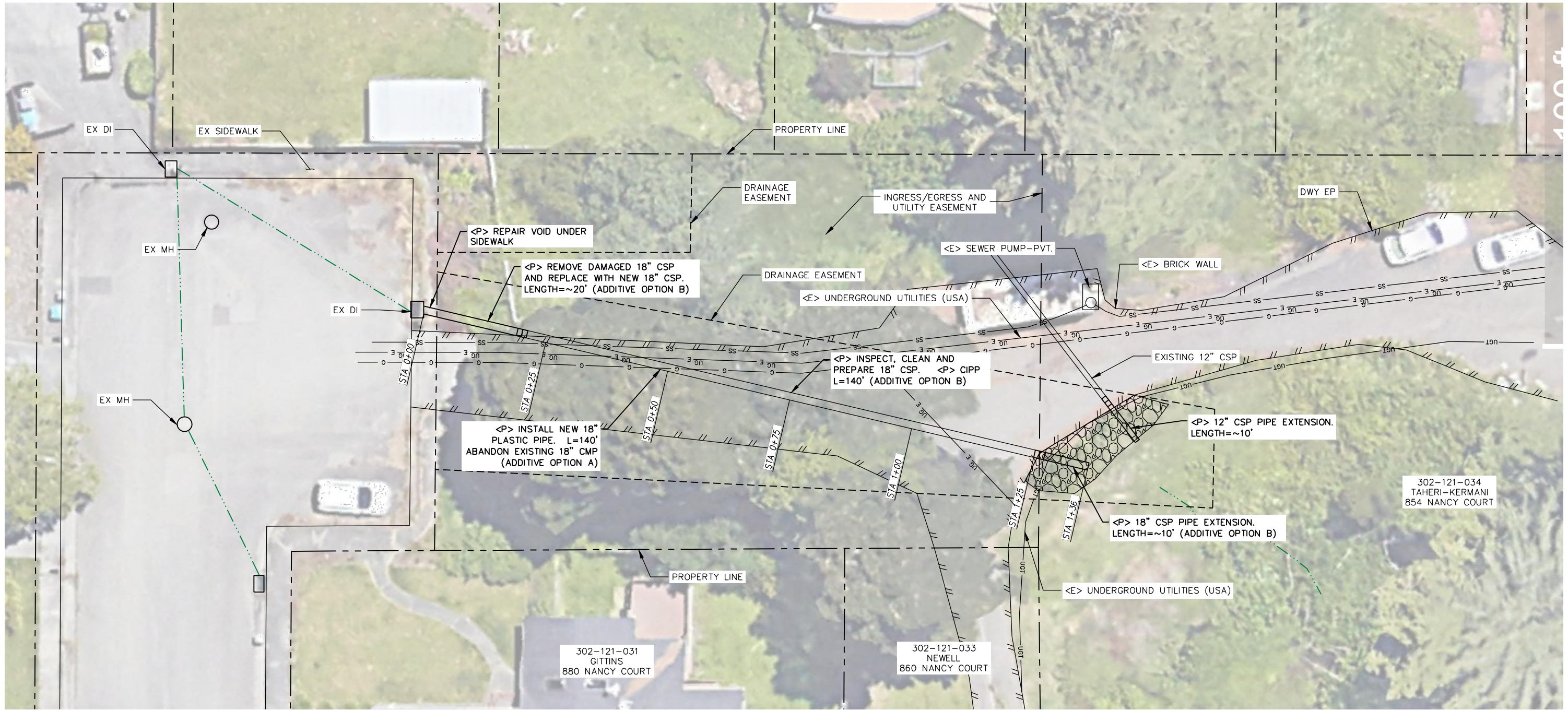

- 3) ADDITIVE OPTION B INCLUDES LINING THE EXISTING & REPAIRED 18" CORRUGATED STEEL PIPE WITH PLASTIC LINER OR CURED-IN-PLACE-LINER. CONTRACTOR MAY SELECTED TYPE AND METHOD OF LINING. CONTRACTOR IS RESPONSIBLE TO INSPECT, CLEAN, AND PREPARE EXISTING 18" CULVERT.
