RE: Letter of Support for the Redwood Christian Center Sign

Attention Humboldt County Planning Commission,

We are writing this letter in support of Redwood Christian Center's sign at 6000 Humboldt Hill Road, Eureka, CA. We have owned the property right next door for over 50 years and their sign has been prominently displayed in the same location in all that time.

I do understand the importance of avoiding excessive nighttime light noise. But, as residents that have lived on Humboldt Hill Road for over 20 years, it has always had inadequate overhead light projection for residents and recreation safety.

The Redwood Christian Center sign has helped illuminate two separate cross walks within 50-75 feet on both sides of the sign that were installed within the past five years. This sign is doing a better job of providing proper illumination in a hazardous area than the counties overhead LED lights. When the sign was hit a few years ago and did not illuminate, there were numerous close calls with people getting hit in the cross walks due to inadequate lighting. My family has personal experience with the situations and did call and report the incidents to the California Highway Patrol, Humboldt County Planning Department and Rex Bohn our District Supervisor.

As we write this letter of support, we walked outside at 8:30 p.m. this evening and the entire bottom of Humboldt Hill is almost completely dark. Meaning, the drivers will not see people crossing the road, which happens to be on a corner until it is too late. At least with the Redwood Christian Center's sign the parents, kids and dogs stand a chance of being seen by the drivers who travel on Humboldt Hill Road. We stand in support of the Redwood Christian Center's sign, one for promotion of their business, and two for community safety.

Greetings,

I am writing to submit public commentary about permit number PLN-2022-17994.

My understanding is that this permit application is for a large video-type electronic sign, which was installed a few years ago without a permit, at 6000 Humboldt Hill Road, by Allpoints Signs on behalf of Redwood Christian Center.

That sign was in operation for a while, and then was shut down via a directive from Humboldt County's Code Enforcement unit because it was not permitted prior to installation, and because it was causing hazardous conditions to drivers, pedestrians, and other users of Humboldt Hill Road and cross streets near the location of the sign. The sign is quite bright in daylight, but at night, it's 'blinding', illuminating far more than the nearby streetlamp does, directly in the face of traffic from both directions on Humboldt Hill Road and nearby cross streets.

Here are my three main points of concern:

A: To the best of my knowledge, a portion of the parcel on which this sign was installed is in the California Coastal Zone, where this type of sign is not allowed at all, but I don't know if the sign itself is in that portion of the parcel.

B: In addition, my understanding is that the parcel is zoned residential, and I don't believe that this type of sign would be allowed without a special use permit and related review phases required for that.

C: The location and brightness of this sign cause hazardous conditions to drivers, pedestrians, and other users of the public right of way near the sign.

I may have my terminology wrong here, but the principal concerns stand.

**I respectfully request that this application be denied, *unless all three of the following conditions are met:***

- 1) The sign type shall be determined by Planning Department Staff to be allowed at this location, in accordance with any zoning and / or coastal zone overlay requirements that may be present.
- 2) The sign and structure that was erected shall be inspected by the Building Department and determined to meet whatever engineering & electrical requirements would qualify it as having been built 'to code'.
- 3) The self-illuminated video sign shall NOT be operated after sunset and before sunrise unless its light output levels are SUBSTANTIALLY dimmed to a level at or below the ambient lumens of the nearby streetlamps, as measured at street level from approaching vehicles in either direction of travel during those sunset-to-sunrise hours daily. *(NOTE: Those hours change each day and seasonally, so an automated control/timer/light sensor system would be required to ensure it operates properly during appropriate hours).*

I have attached prior correspondence with Code Enforcement about this particular sign, along with a video demonstrating how overly bright this sign is at night, causing a clear and present safety hazard when in use between sunset and sunrise.

When a new, video billboard was installed after the prior illuminated sign was installed, it was apparently not permitted, and is not allowed in this location due to the zoning this parcel is in.

Not only is it not an allowed type of signage in this location, it is exceedingly bright after dark - it does not appear to auto-dim when the sun sets. It is very distracting and causes visibility problems for drivers on Humboldt Hill road from both directions (it's a two-sided video billboard).

I have included a video file of the sign, which was taken at twilight, before full darkness - it's even worse after dark. The latter part of the video demonstrates that parts of the video content they display completely 'daylights' Humboldt Hill Road, far brighter and larger than other vehicle's headlights, making it impossible to see pedestrians, animals, and even other vehicles while the sign is in view.
