RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING EXECUTION OF COOPERATIVE FIRE PROGRAMS – FIRE PROTECTION REIMBURSEMENT AGREEMENT NO. 1CA06883 WITH THE CALIFORNIA DEPARTMENT OF FORESTRY AND FIRE PROTECTION REGARDING THE PROVISION OF FIRE PROTECTION SERVICES WITHIN HUMBOLDT COUNTY

WHEREAS, CalFIRE has offered to provide certain fire protection services in support of the local fire protection districts with Humboldt County; and

WHEREAS, the County of Humboldt ("County"), by and through its County Administrative Office, have determined that there is a need for CalFIRE to provide such fire protection services within Humboldt County.

NOW, THEREFORE, BE IT RESOLVED that the County of Humboldt Board of Supervisors:

- Hereby authorizes the Humboldt County Administrative Officer, or a designee thereof, to execute
 and deliver, in accordance with any and all applicable local, state and federal laws, regulations and
 standards, Cooperative Fire Programs Fire Protection Reimbursement Agreement No.
 1CA06883, and any amendments thereto, along with any and all other certifications, agreements
 and documents required or deemed necessary or appropriate for the County to accept and secure its
 obligations thereunder.
- Hereby certifies and represents that it will accept CalFIRE's provision of fire protection services in a manner consistent, and in compliance, with the terms and conditions set forth in Cooperative Fire Programs – Fire Protection Reimbursement Agreement No. 1CA06883, as well as any and all applicable local, state and federal laws, regulations, standards and contractual requirements.
