

**THIRD AMENDMENT
AGREEMENT FOR LEGAL SERVICES
BY AND BETWEEN
COUNTY OF HUMBOLDT
AND
MURPHY AUSTIN ADAMS SCHOENFELD LLP**

This Third Amendment to the Agreement for Legal Services dated October 2, 2018, as amended on February 28, 2023 and March 20, 2025, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as “COUNTY,” and Murphy Austin Adams Schoenfeld LLP, a limited liability partnership, hereinafter referred to as “ATTORNEY,” is entered into this ____ day of _____ 2026.

WHEREAS, COUNTY, by and through its County Counsel’s Office, desired to retain a qualified professional organization to provide legal assistance with construction-related matters on an as-needed basis; and

WHEREAS, on October 2, 2018, COUNTY and ATTORNEY entered into an Agreement for Legal Services (“Legal Services Agreement”) regarding the provision of such legal assistance; and

WHEREAS, on February 28, 2023, COUNTY and ATTORNEY agreed to amend the Legal Services Agreement in order to adjust the rates of compensation set forth therein; and

WHEREAS, on March 20, 2025, COUNTY and ATTORNEY agreed to amend the Legal Services Agreement in order to adjust the rates of compensation set forth therein; and

WHEREAS, COUNTY and ATTORNEY now desire to amend certain provisions of the Legal Services Agreement in order to further adjust the rates of compensation set forth therein.


NOW THEREFORE, COUNTY and ATTORNEY mutually agree as follows:

1. The Legal Services Agreement is hereby amended to delete “Exhibit A to Agreement for Legal Services (Second Amended)” (“Exhibit A”) and replace it in its entirety with the modified version of Exhibit A that is attached hereto and incorporated herein by reference as if set forth in full. The modified version of Exhibit A attached hereto shall supersede any and all prior versions thereof as of January 1, 2026.
2. Except as modified herein, the Legal Services Agreement dated October 2, 2018, as amended on February 28, 2023 and March 20, 2025, shall remain in full force and effect. In the event of a conflict between the provisions of this Third Amendment and the original Legal Services Agreement, or any prior amendments thereto, the provisions of this Third Amendment shall govern.
