WHEREAS, CalTrans and the County of Humboldt, pursuant to Streets and Highways Code section 114 (b), are authorized to enter in this Agreement affecting State highways within the jurisdiction of Humboldt County; and

NOW, THEREFORE, BE IT RESOLVED that Humboldt County Board of Supervisors hereby accepts and agrees to abide by the terms and conditions of the Cooperative Agreement #01A1939 with CalTrans for the implementation of the supervised inmate work crew project for a three-year period from July 9, 2019 through June 30, 2022; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that Humboldt County Board of Supervisors hereby authorizes the Board of Supervisor's Chair and the Humboldt County Sheriff to execute and submit all documents including, but not limited to the Cooperative Agreement and any amendments, revisions, and extensions for the duration of the project.
