Dear Mr. McGuire,

As you are aware, Code Enforcement has an open case on your property located at 6766 West Avenue, Fields Landing, CA, APN: 306-024-004 for violations of Humboldt County Code related to maintaining a junkyard (HCC 371-2), the improper storage and removal of solid waste (HCC 521-1, 521-4, 521-12), and the property use in violation of Zoning Codes (311-10.1).

On February 28, 2023, you were served with a Notice to Abate Nuisance and a Notice of Violation and Proposed Administrative Civil Penalty for the conditions and violations observed on your property.

You have not requested a Code Enforcement Appeal Hearing or a Compliance Agreement in the timeframe allowed in the Notice to Abate Nuisance. Additionally, as of November 2, 2023, you have not completed the corrective actions listed in the Notice to bring your property into compliance and Code Enforcement continues to receive numerous complaints regarding the condition of your property.

Consequently, the County has jurisdiction to abate the property.

This letter is to inform you that the County intends to move forward with abating the public nuisance, which includes but is not limited to the removal of solid waste, junk, salvaged materials, construction materials, RV, and items being stored on the property.

Additionally, the costs of the required abatement may become a charge against your property and may be collected at the same time and in the same manner, and shall be subject to the same penalties, interest and procedure of foreclosure and sale in the case of delinquency, as is provided for ordinary property taxes. In addition, the costs may also become a charge against your property which has the same force, effect and priority of a judgement lien governed by the provisions of California Code of Civil Procedure Sections 697.31, et seq., and may be extended

as provided in California Code of Civil Procedure Section 683.110, et seq.

Currently an Inspection Warrant and Order of Abatement is being drafted and sought in order to conduct a county abatement of the property. We are unsure when the abatement will commence but estimate around the beginning of December 2023.
