I. Call to Order

II. Review and approval of minutes – May 19, 2021

IV. Crisis Intervention Training and Train the Trainer – Action Item \$40, 000

Eureka Police Department proposes hosting training for 20 sworn staff and 10 staff to be trained as trainer of curriculum.

Chief Watson turned the presentation over to Sargent La France to present this action item.

- \$40,000 funding request.
- The company providing the training is Solution Point+, LLC.
- The training package includes: 24-hour CIT train-the-training class; 40-hour county-wide CIT core class, and audit/consulting.
- The primary focus of this request is to add another CA POST certified CIT program in Humboldt County.
- There is a current need for two CIT programs in Humboldt County to meet the needs of the community.

- Increased mental-health needs.
- Law Enforcement is being asked to address these challenging issues.
- Increase street and field level knowledge of mental-health issues.
- Eureka Police Department will take the lead on this training and coordinate/partner with the Humboldt County Sheriff's Office.

A discussion took place regarding this action item.
