Dear Supervisors,

I learned of this item of discussion yesterday afternoon, and will also try to call in.

Firstly, I do not see a rationale presented to you for a reduction in size of the commission. A presentation of a statistical subset is not a rationale, but rather, is a presentation of a data sample without argument for or against a 5 vs 7 member PC.

The American Planning Association (APA) has published numerous articles on this topic, and on the role of the PC generally; I have linked the longer review article below. It is an interesting read.

However, much of the debate centers on whether a PC is needed or helpful, given that planning is now a "mature" discipline, rather than the size, and on the characteristics that define what an effective planning commissioner is; integrity, planing knowledge and interest were the two most important in the APA's surveys and studies.

This is because it is already established that a higher diversity of voices from different educational profiles, backgrounds and experiences, improves all decision making processes.

Much of the recent literature has examined the successes emanating from a stronger presence of women on Corporate and other Boards, for example.

A Commission of 7 also removes much of the risk of not achieving quorum, which is frequent in Counties with 5 members. Given that we have double the number of hearings relative to other Counties, due to the many projects that must go through a hearing, this would be particularly unwise here, as Humboldt County has hundreds of applications in queue and cannot afford to reduce the number of hearings.

This proposal therefore gives the perception that the County is looking at decreasing diversity and representation in the public process while running a risk of slowing the permitting process.

I have also been told that there is the perception that this is a convenient way to remove myself, for purported conflict of interest reasons. I would hope that this is merely a rumoured perception, as an example of bias towards my employer, or any other group over the many years I have served on the Arcata and Humboldt County PCs does not exist. I do not serve on other Boards, Commissions, and do not benefit financially or otherwise from any decision made, and indeed, have voted to approve many projects that negatively affected myself, my family, home, and/ or employer. I take the role very seriously.

Concern from another Government and the Planning Department that somehow the Bear River Band has an " unfair advantage" is unfounded, and against the clear evidence of objective decision making I have made.

Further, it should be noted that unfortunately, there is a perception that our governmental bodies lack transparency. Removing people without bias from appointed positions for reasons of bias could only worsen our image, while decreasing diversity in decision making and slowing the permitting process due to potential quorum issues.

Dear Supervisors,

I intend to speak in person before you on Tuesday regarding this matter, if I can make the timing work. But in case I cannot be present for that item, I wanted to get my brief thoughts about it onto the record.

I strongly believe that the Humboldt County Planning Commission benefits from having seven members rather than five. I say this regardless of the individuals who currently happen to be in the at-large seats, but more generally as a matter of how we function. I believe that we are capable of doing better work as a body, reaching better outcomes, and are more able to move a greater number of projects through our process when we have seven capable, committed members of the body available, rather than five. Quite simply, I fear that removing the at-large seats and reducing our number will result in worse outcomes for the projects that come before us, and will further slow the process of getting projects approved.

I know that staff has presented evidence that the majority of surveyed counties have only five commissioners, not seven. But what this fails to capture is that the Humboldt County Planning Commission actually has a significantly bigger workload than most other comparable counties do. I know this as a matter of personal experience because I have served on the Executive Committee of the California County Planning Commissioner Association (CCPCA) for the past three years (including serving as its President in 2020-21, and organizing its conference in Eureka a year ago). I have personally compared my experience with several dozen commissioners in this capacity, and have reviewed the agendas of perhaps 20 other county planning commissions in my efforts to publicize our conference last year. It is simply a fact that most counties do not process the same number of items through their planning commission as Humboldt County does — indeed, many comparable counties do not even regularly hold two planning commission meetings a month.

If you remove two of my fellow commissioners, you simply shift that same total workload onto fewer shoulders. The work will not be done better, but the burden will be greater on those of us who already do this very time-consuming and demanding work for no compensation other than a small stipend.

I support the staff's other recommendations regarding rules and procedures pertaining to the Planning Commission, but I urge you to reject the staff's proposal to remove the at-large seats.
