Therefore, I urge the Board of Supervisors not to cut from the Health and Human Services Department. We need to keep funding Behavioral and Public Health, especially during these times of living in a pandemic. Our community members are facing eviction, loss of jobs, decrease in wages and economic instability which then leads to an increase in mental health issues and a need for secure shelter.
