To: Measure Z Committee and Humboldt County Board of Supervisors:

The City of Eureka and the Eureka Police Department (EPD) have been at the forefront in addressing the homeless, mental health and addiction issues which affect our communities. Since the conception of Measure Z, funds have been awarded to EPD to institute progressive and new approaches to address these issues. Over the past 5 years, EPD has partnered with Humboldt County Department of Health and Human Services (DHHS) in forming our Mobile Intervention Services Team (MIST). This team has prioritized clients who are in the greatest need, providing the compassionate care and assistance they need to find stabilization. As with any program, its success requires the program to stay fluid and change as those we serve change. MIST has accomplished this and its partnership with DHHS remains strong, and the success stories continue to show the value in this program.

In June 2018, EPD formed a new team, Community Safety Enhancement Team (CSET), to further support the city and our citizens in addressing the issues mentioned above. This team, consisting of a Sergeant, two (2) Parks and Waterfront Rangers (1-funded by Measure Z), our MIST Officer (funded by Measure Z) and our Old Town Officer, works together to support one another in their individual positions. CSET Mission Statement: *To proactively address quality of life, crime and disorder problems in Old Town, along the waterfront, and in city parks while developing strategies to ultimately improve upon or eliminate these issues.* The forming of this team has strengthened their ability to engage our most vulnerable community members and provide resources and assistance while balancing the need for enforcement to ensure accountability and livability for our citizens.

The City of Eureka has taken further progressive steps to provide long term solutions by creating a program called UPLIFT Eureka. This program, whose coordinator and Homeless Outreach Workers are Measure Z funded, works in

conjunction with CSET to address a specific portion of our population and help them find stability and a positive place in our community. These collaborative programs like MIST, CSET, and UPLIFT Eureka are increasingly providing the city with new tools and options beyond enforcement to make positive change. The outreach, communication, relationships and direct linkage to services are key components to our homeless strategy. Their impact has been felt and seen daily by both our citizens and business and I receive positive feedback regularly during meetings and encounters within the community.

As stated by Chief Watson in the City of Eureka's response to the Humboldt County Civil Grand Jury report titled "Les Misérables", "We know that enforcement alone will not solve the problem of homelessness. Outreach and services are also central components in our response to this crisis. Together we must find innovative and humane approaches leading to real, lasting solutions. May our community stand upon this common ground and work together toward our shared goal of ending chronic homelessness." The efforts of CSET, MIST and UPLIFT Eureka are prime examples of this increasingly balanced and comprehensive strategy. Measure Z funding is essential to ensuring these innovative and successful programs are allowed to continue to grow and serve some of the most vulnerable members of our communities.

On behalf of the City Council and myself, we encourage the Measure Z Committee and the Humboldt County Board of Supervisors to fund in full, the Eureka Police Department's Measure Z application. These funds will allow our units and programs to continue to lead the way for the City of Eureka and the County of Humboldt as we all navigate the homeless crisis in our county.

The Humboldt County Department of Health & Human Services (DHHS) would like to express our support for the City of Eureka Community Safety Enhancement Team (CSET) and their application for Measure Z funding.

Measure Z funding to date has facilitated the collaboration between the City of Eureka and DHHS programs which have resulted in increased outreach activities to more effectively address the issues surrounding homelessness in our area. CSET works alongside our Mobile Intervention & Services Team (MIST) to directly assist homeless individuals in our community. The partnership between CSET and MIST has improved outreach, intervention and support services since its inception in 2015, resulting in the chronically homeless and severely mentally ill receiving more timely and intensive support. I am writing on behalf of the Board of Directors of the Greater Eureka Chamber of Commerce to urge the Citizens' Advisory Committee to approve the Eureka Police Department's 2020-21 Measure Z funding application.

The Chamber recognizes that the homelessness crisis in our region has significant impacts to individuals and families, Chamber members, and the local economy. We believe that Measure Z funded positions and programs including EPD's Community Safety Engagement Team (CSET) and the Eureka Community Services Department UPLIFT program are vital to addressing this problem.

The EPD MIST Officer, Parks and Waterfront Ranger, Homeless Outreach Worker, and Homeless Services Coordinator are essential to building trust and relationships with homeless individuals and connecting them with the services they need. Working together with a number of local service providers including the UPLIFT program, CSET has a proven track record of effectively engaging individuals in crisis and moving them off the streets and into mental health counseling, substance abuse programs, shelter, and permanent housing.

We believe the CSET program has proven cost effective. The program has also been instrumental in cleaning up many thousands of pounds of trash from Eureka's waterfront, parks, and city properties.

In addition to their work with homeless, EPD's CSET team is very responsive to the concerns and inquiries of local organizations including the Greater Eureka Chamber of Commerce. Such willingness to coordinate community, business, and government stakeholders is vital for the long term success of any program to address homelessness, substance abuse, and mental illness in our area.

In addition to the direct results of CSET and UPLIFT's mitigation of homelessness in Eureka, these programs are yielding important benefits including workforce development, cleanup of Eureka's beautiful city parks and waterfront trail, and improvement of the Old Town/downtown atmosphere to create a safe and inviting experience for tourists and locals alike.

I am writing this letter in support of the Eureka Police Department's request for Measure Z funding. Eureka Main Street is California's largest Main Street community with 49 blocks of commercial and residential uses. We also have about 90% of all social service programs within, or on the fringe of, our District.

We are all aware that what happens in Humboldt County directly affects Eureka's ability to maintain a vibrant community where people want to live, work and play, as well as enhance a thriving, visitor serving, destination. Measure Z funding is predicated upon sales tax revenue. Therefore, it is critical that our District stay healthy in order to increase those monies. The ongoing efforts of CSET, MIST, and its newer program UPLIFT Eureka, are helping us maximize opportunities to showcase our uniqueness from Victorian architecture, live theater, mural walks, and outdoor events, to mariculture, kayaking, rowing and sailing, and bay tours on the Madaket.

The Eureka Police Department's community approach to the social and criminal issues that are tied to homelessness, drugs/alcohol abuse, and mental health problems is proving successful. These programs are demonstrating how effective they are at helping those on the streets connect with support services. Measure Z funding is necessary for our police to continue the level of service needed to operate these valuable programs.

In addition to those programs, Community Services launched a Co-Pilot project that involves a one-on-one partnering of a citizen volunteer (co-pilot) with an individual (participant) seeking support. Together they create a bond that is leading the participant to a quality of life that is productive. I am a Co-pilot and have worked with participants who have successfully found work, housing, and most importantly reclaimed their independence, and dignity. It is a marvelous experience!

This is certainly the time to continue investing Measure Z funding. It is a great feeling to notice an increase in community members and visitors out walking dogs, riding bikes with their children, shopping and dining, or just taking in the beauty of our waterfront. These are all activities that sustain a healthy community and improve the quality of lives for everyone.

Thank you in advance, for considering, and supporting, EPD's request for Measure Z funds. It is my hope you will fund them at the full level they have requested.

Dear Measure Z Board:

Please accept this letter of support for the City of Eureka's request for Measure Z funding to support their police department's Community Safety Enhancement/Engagement Team (CSET) and their complimentary Uplift Eureka program. I consider both programs to be valuable partners in addressing homelessness and reducing negative impacts in our community due to behaviors associated with homelessness.

I connect with some of the most vulnerable in our community each day, as the Coordinator of the Eureka Community Resource Center, an outreach program of St. Joseph Health — Humboldt County. Located inside the St. Vincent de Paul Free Dining Facility, I'm in the perfect place to engage with those experiencing homelessness, substance used disorder and/or mental health challenges. These along with food insecurity, are complex community issues that require strong partnerships in order to address them successfully.

In the last couple of years, I've created a partnership with CSET, who come down to my site on a regular basis. I believe that part of their role is to change the perception of the police department with those who regularly interact with law enforcement. They act as an additional resource to connect people with local services and get people the help they need to make long lasting life changes. In order for CSET to be successful with this population, they must build trust, which takes time and consistent messaging.

In addition to my partnership with CSET, I've referred people to the Eureka Uplift program. This new program, provides additional support for those experiencing homelessness. Navigating local resources can be an exhausting endeavor and the Uplift's co-pilot program pairs community members with liaisons that can not only guide them, but join them on their journey to establishing housing.

Homelessness is a nationwide epidemic tied to many social factors, and is felt even more so in rural areas that have a tolerable climate. During the 2019 Point in Time Count, more than 1,470 unsheltered people were counted in Humboldt County, with the majority (653) counted in Eureka. This community issue cannot be addressed by any one organization, and requires a collaborative approach with innovative ideas. I believe the City of Eureka's CSET and Uplift programs fall into that category, and Measure Z funding is critical to sustain and expand upon these type of services.

CSET's activities provide public safety and promote collaboration between the Department of Health and Human Services- Mental Health (DHHS- Mental Health) and Law Enforcement officers through shared field work and the common goal of supporting individuals experiencing homelessness with obtaining stable housing as well as substance use disorder and/or mental health treatment.

This program has helped me secure employment in the field of my dreams. When I first entered the Uplift program I started out as a volunteer in the job skills training program. My duties were trash clean up and graffiti removal in the Eureka Old Town area, and assisting in major cleanup projects with the Eureka Police Department. At this point, I had doubts that the program would be able to help me with my desire to enter the Security industry, but Jeff Davis told me to trust the system and he informed me about the Pathway to Payday program.

The Pathway to Payday is a program that is a collaborative partnership between the City of Eureka's Community Services Department and the Betty Kwan Chinn Day Center. It's a four-session, intensive workshop, open to the public, designed to provide participants with the skills necessary to successfully seek employment.

The program built my self- confidence and self-esteem by having me search for jobs and teaching me the best way to navigate searching for a job. I completed job applications, participated in mock interviews and speed-round interviews with real businesses. At the end of the mock interviews, the interviewers would provide me with constructive feedback and ways to improve my presentation which really helped me with the speed-round interviews. I applied for a job with the City of Eureka, Uplift program, Crew Leader, interviewed for the position and was hired.

While working for the Uplift program, I sought employment in the Security industry. I used the skills that I gained through Uplift and secured a job with Loomis Armored Car Services. I'm so grateful that you, the Humboldt County Board of Supervisors, assist in making programs such as the Uplift program available. I'd also like to thank Jeff Davis, Uplift, for telling me to trust the system and Drake Goodale, EPD, for inspiring me. Next, I volunteered for their Eureka Beautification aspect of the program. We met twice weekly, we cleaned trails, removed graffiti, picked up trash. Soon they offered a Co-pilot program. Volunteers from the community met with us on a weekly basis to assist with everything from obtaining ID's, to putting us in touch with local resources. I knew I was moving in a positive direction.

Pathway to payday was a life changing Esperance for me. The workshops on the first day where very informational learning what employers expect what our rights as employees are that there are things that an employer can't ask you. I was struggling with my resume skills. I learned a lot of skills incarcerated. The ladies taught me what words to use and how to put them down on a resume without saying where I'd learned them. The mock interviews helped me to learn how to sell myself to prospective employers. I learned not only how to answer questions but how to ask question and what questions to ask. I could feel my confidence building. Being able to get interview clothes took a lot of stress off of me. By the end of the second day I felt like I was employable. They also helped me get my state ID and my children birth certificates.

The third day I interviewed for four jobs. I was hired by three I now work two of those jobs. One of which is assistant crew lead for uplift. The other is at best western. If it wasn't for uplift and pathway to pay day I don't know where my life would be. I now have both of my children with me and a home. I'm currently working to get my driver's license.

My co-piolet helped me get organized with doctor's appointment and mental health. She gave me support that I didn't know that

Dear Measure Z Committee,

I am not sure what Eureka will be requesting, however I need to write before leaving for a couple weeks.

I have advocated for moving the system from law enforcement management of people to the Housing First approach using a camp. This would be a stop-gap measure to end the current system that relies on law enforcement to manage people without housing. The courts address one law at a time as they evaluate the toolbox of laws used to manage people. Recently I learned some think a ticket for littering may be a good thing an officer can give someone. Perhaps nudging people with a ticket is better than waiting for people to hit bottom and hoping emergency services will get to them in time. But this system of handing out tickets to nudge people into services, though I hope and believe is well intentioned, is criminalization of poor people and a misuse of our criminal justice system.

Some advocates think what is needed is storage for people's things, or another day center, or a place to park for people with a license and registered vehicle. I wonder if the people they are speaking for are the people the EPD Officer was referring to when he said some people would not come to a camp. This may sound harsh, but I assume they probably are not needing a camp and will probably be fine. I also think they may find a camp operated under regular tenancy rules (also a Housing First principal) works for them, too.

I know some advocates find the idea of a camp disturbing. I do. But I find even more disturbing the idea of using law enforcement to manage people; writing tickets for petty offenses as the pathway to housing or as an "incentive" to enter a program. The rental market is tight, home ownership is out of the question for many, if not most. We need an option that is based on Housing First principals. Low barrier and under a tenancy agreement, such a camp is civil rights not bogus criminalization, a place where charity is an act of kindness that adds to a life rather than an attempt to save one.

"The criminalization of homelessness refers to practices of enforcement that disproportionately impact people who are homeless. For example, there is an increased police presence and increased engagement with people who are homeless. Another example, the language of 'public safety,' 'social disorder,' and 'restoring order' is used by officials while at the same time there is more engagement with police, rooting out of misdemeanors, and confining use of public space." (*The Book on Ending Homelessness*, Ian De Jong, Friesen Press, 2019)

After three or four years of requests that included housing assistance administered by DHHS, it was not included in last year's EPD request. There may be a request this year from Eureka's Uplift program for housing assistance funding. It has been well documented that Housing First reduces emergency services costs, as well as mental health services costs. Measure Z funding would go farther, do more if used to fund a camp rather than in the very tight rental market.

Please provide funding for a camp if this part of a request. If not, please ask if Eureka would agree to use any housing assistance grant for a camp and if so, please provide Measure Z funding.

The Shelter Cove Fire Department, part of the Resort Improvement District Number 1, fully endorses the Humboldt County Public Works application for Measure Z funding. The Humboldt County road system may be one of the most overlooked aspects of public safety in the entire county. While local police, fire, and EMS agencies are vital to the well-being of county residences, none of us would be able do our jobs and safely access people in need without a safe and maintained county road system.

One of these lifelines is the stretch of county road between Shelter Cove and Redway. Just this road and the roads that connect to it serve six volunteer fire departments, two Cal Fire stations, and City Ambulance out of Garberville. All these departments use county roads to access people who are hurt, need help extinguishing structure fires, or even utilize them as fuel breaks to stop wildland fires. Just this year a failed culvert outside of Redway shut Briceland Thorn Road down. The detour around Old Briceland Road added an hour, to the already almost hour-long commute for the ambulance responding to the Shelter Cove area. In Shelter Cove alone the lack of funding for county roads maintenance has led to numerous potholes, overgrown roads, and failed culverts, which took out water lines supplying over a dozen fire hydrants.

While the state of the Humboldt County roads may not be as obvious as showing off a new fire engine or seeing more law enforcement officers on the streets, when it comes to the safety of the public in Humboldt County all the entities that have been funded in the past rely on the Humboldt County road system in order to utilize many of the benefits they have already gained through Measure Z. The Shelter Cove Fire Department feels strongly that the Humboldt County Public Works application for Measure Z funding be awarded in full ensuring the county roads are in a condition that allows our first responders to rapidly and safely access the people in need.
