RESOLUTION AUTHORIZING A DETERMINATION OF PUBLIC CONVENIENCE RELATED TO THE  
ISSUANCE OF A TYPE 42 ALCOHOLIC BEVERAGE LICENSE FOR THE BED AND BREAKFAST INN  
LOCATED AT 118 DOLPHIN DRIVE, WHITETHORN, CALIFORNIA

**WHEREAS**, Simy Rajan, owner/operator of the bed and breakfast inn located at 118 Dolphin Drive, Whitethorn, California has applied to the Department of Alcoholic Beverage Control for a Type 42 alcoholic beverage license; and

**WHEREAS**, a Type 42 alcoholic beverage license allows both beer and wine to be sold and consumed at the location; and


**WHEREAS**, the bed and breakfast Inn owned by Mr. Rajan is located in an area where there is an over-concentration of alcoholic beverage licenses and the decision regarding issuance of this license will be decided by the Department of Alcohol Beverage Control on its own unless the Board of Supervisors makes a determination as to whether the license would serve as a public convenience or necessity; and

**WHEREAS**, the Humboldt County Board of Supervisors reviewed and considered this request at its regular meeting on June 3, 2025.

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:**

1. The Humboldt County Board of Supervisors hereby determines that the issuance of a Type 42 alcoholic beverage license for the bed and breakfast inn located at 118 Dolphin Drive, Whitethorn, California, will be a benefit to the community and serves as a public convenience.
