WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

- 1. Adopt the amended Compensation Plan Between the County of Humboldt & Elected & Appointed Department Heads effective October 25, 2022 December 31, 2024 effective the pay period following board approval;
- 2. Adopt the amended Compensation Schedule effective September 14, 2025 (Attachment 2) effective the pay period following board approval to increase the salary of the Director of Aviation
