ANNUAL REPORT

This report describes the activities of the Code Enforcement Unit (CEU) during the 2021 calendar year.

ACCOMPLISHMENTS

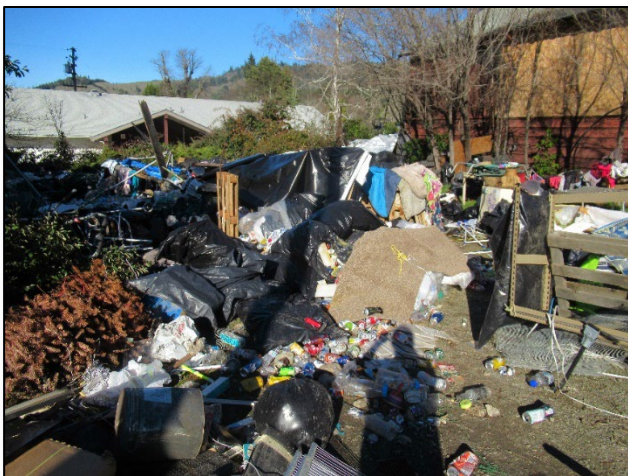
Establishing List of Pre-Qualified Abatement Contractors

In early 2021 the county entered into agreements with eight contractors and consulting firms for the purpose of having a prequalified list of contractors to select from for county abatements. Having a prequalified list of contractors has greatly reduced the time involved with performing county abatements. The result of streamlining this process is evident in the number of abatements performed in 2021 which has quadrupled over last year.

Abatements

For some of CEU's cases the property owner is unwilling or incapable of dealing with the public nuisance located on their property. In these situations, as a last resort and after repeated attempts to get the property owner to perform the abatement, the county will step in, after properly serving notice and obtaining jurisdiction, to perform a county abatement. The county obtains jurisdiction to abate a nuisance once the 10-day Notice to Abate Nuisance is served and the property owner neither abates the nuisance nor requests an appeal hearing.

In 2021 there were four cases that resulted in county abatement. The first was the demolition of a fire-damaged church on Elm Street in Garberville that had become an attractive nuisance for the community. In addition to the dangerous condition of the building, there was a vast amount of solid waste accumulating in the property and the community was demanding enforcement. The violations on the property were abated in February.

The second county-led abatement involved a long-standing case on Walnut Drive in Eureka. This residence had numerous substandard housing violations and the property was littered with solid waste and junk vehicles. In April, the solid waste and vehicles were removed from the property and the residence was boarded-up to prevent entry. The county recorded a lien on this property for the cost of the abatement. The property is expected to be auctioned in 2022 and the county will be in a position to recover the costs associated with the county abatement.

The third abatement took place on Third Street in Fields Landing. The property owner was making extensive renovations to the residence that rendered the structure dangerous. The property around the residence was full of solid waste and was spilling out to the street. The abatement was completed in July.

The last abatement for 2021 was a motel in Orick that had flagrant substandard conditions. The process for this abatement required the county to progress in phases. First, the county issued relocation benefits to the registered tenants. Then the structures making up the motel were boarded-up to prevent entry and the solid waste littering the exterior was removed. In preparation for demolition there was asbestos and lead-paint testing performed and the buildings were fumigated to prevent the cockroaches, bedbugs and rats from entering the community when the buildings were demolished. These phases of the abatement occurred in October through early January 2022. The last phase will be the demolition.

HEIR (Humboldt Environmental Impact Reduction) Cases vs. Law Enforcement Search Warrant Cases

There were 200 new cannabis cases in 2021. There were 111 new HEIR cases and 89 cases that originated from accompanying law enforcement search warrants. And of the cannabis cases closed in 2021, 119 were HEIR cases and 66 originated from accompanying law enforcement on search warrants.

STAFF

With the 2021/2022 fiscal year, the Board allocated two additional positions to the Code Enforcement Unit and those vacancies were filled in November and December of 2021. Seven of the ten Code Enforcement officers and investigators are certified by CACEO – the California

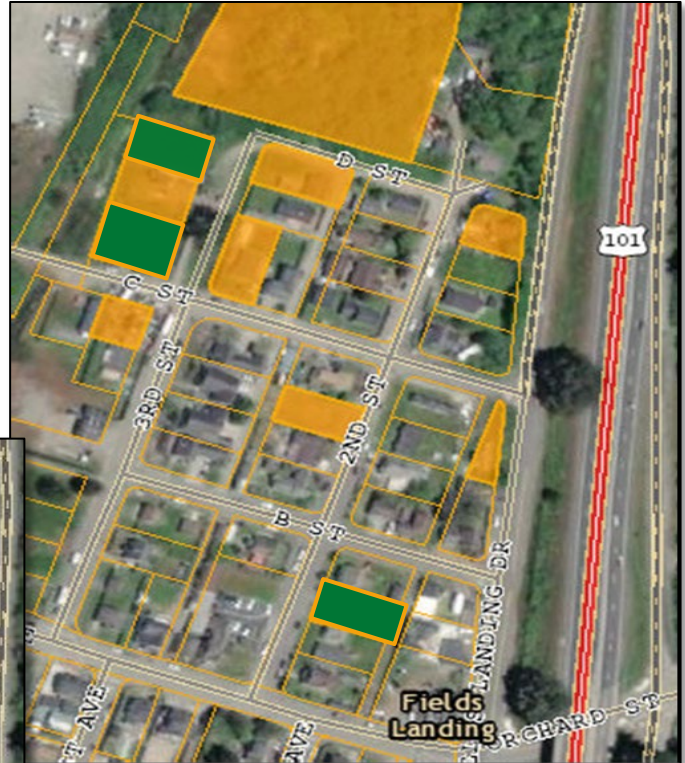

Association of Code Enforcement Officers and the remaining 3 staff members will be fully certified by July 2022. Certification involves a minimum of 120 hours of training in multiple topics related to code enforcement.

PROGRESS

Previous annual reports described a situation where there was a backlog of cases that had yet to be reviewed, with more cases being opened each month than closed.

To address that issue the unit launched a widespread campaign in early 2021 to verify the validity of the complaints and cases that had accumulated. The effort was successful. The unit was able to close 25% of the previously unreviewed cases by reviewing internal data such as satellite imagery and permitting, or by driving by the property to either document the issue or determine that the complaint was unfounded.

Another approach that was implemented to address the backlog of cases was to focus on a geographic area with a high density of cases. Fields Landing stood out as area where deliberate and simultaneous enforcement action would make an impact. There was community outcry over the situation in the north end of Fields Landing which included a massive homeless encampment, an easement blocked with junk vehicles and solid waste and several residences where junkyard

conditions persisted. Code Enforcement staff worked with the property owners of these properties who, for the most part, successfully abated their violations. One property owner successfully evicted a tenant who was the cause of several violations within an easement. Another creative approach was when the property owner of the homeless encampment, who lived out of the area, had the occupants of the camp remove the tons of solid waste and garbage that had accumulated in exchange for the property owner assisting the occupants in finding alternative housing. The county ultimately conducted an abatement of another Fields Landing property with numerous violations. While the experiment to focus on a geographic area was effective in Fields Landing it required a lot of dedicated staff time, which meant other cases were temporarily sidelined. It became apparent that there were too many geographical areas needing attention to continue to implement this approach.

Toward the end of 2021, the newly allocated positions provided the bandwidth required to completely redevelop the CEU processes and reorganize the workload. The new process mimics the efficiency of the cannabis case process by using automated letters to inform property owners, and complainants, of the status of a case. First, a letter is sent to the property owner when a new complaint is received. Within 2 weeks of receiving the complaint, staff reviews internal data, satellite imagery and permits. If needed, a drive-by inspection takes place or another letter is sent requesting a consent inspection. These activities are designed to determine the validity of the complaint. Once it is determined a violation exists, the property owner is sent another letter informing them of the existence of the violation and the corrective action needed to abate the violation.

If the property owner does not contact the department or correct the violations within the grace period, then the property will be served notices which will be recorded after the 10-day appeal period. The purpose of serving and recording notice(s) is to formally document the issues on the property and provide proper notice to any potential buyer(s).

This new process is designed make efficient progress in 95% of the cases. There will always be cases where the specifics of the case do not fit into the mold of the new process, but the goal was to be able to address the back-log through a systemic approach.

The new process was implemented in November and the unit has seen immediate results. In 2021, there were 425 new cases opened but there were 616 cases closed. This is a reversal of previous years when there were more cases opened than closed. Of the 425 cases that originated in 2021, 147 of them have been closed, 68 of which were closed because the complaint was unfounded.

FUTURE OBJECTIVES

1. Code Enforcement is beginning to use HCC section 353-1 *et. seq.*, Use of Buildings for Sale of Controlled Substances Prohibited. This county ordinance authorizes Code Enforcement to act against persons conducting or maintaining the nuisance of unlawful selling, serving, storing, keeping, manufacturing or giving away of any controlled substance within any building in the unincorporated areas of the county. The process outlined in this section is different than the familiar Code Enforcement process and requires filing court documents for obtaining temporary restraining orders against the use of the property.
2. Code Enforcement will address the complaints of light pollution violations for cannabis operations. These are cannabis operations that fail to meet the Performance Standards for Light Pollution Control in HCC sections 313-55.4.12.4 and 314-55.4.12.4. Consistent enforcement on this issue has been lacking and it is the intention of Code Enforcement to proactively address the flagrant number of uncovered greenhouses.

3. Homeless encampments are another area Code Enforcement intends to address. There are challenges related to established homeless encampments which include tenancy rights for occupants.
4. Receiverships is another area for Code Enforcement to expand into. A receivership is authorized pursuant to CA Health and Safety §§ 17980-92 and HCC section 351-27

which allows the county to abate a public nuisance through a civil action in the Superior Court. A health and safety receivership is a legal process through which title to a piece of real property is temporarily taken from the owner and placed with a court-appointed officer – the Receiver. Receiverships would be used primarily for abandoned and substandard properties where the owner has a history of non-compliance.

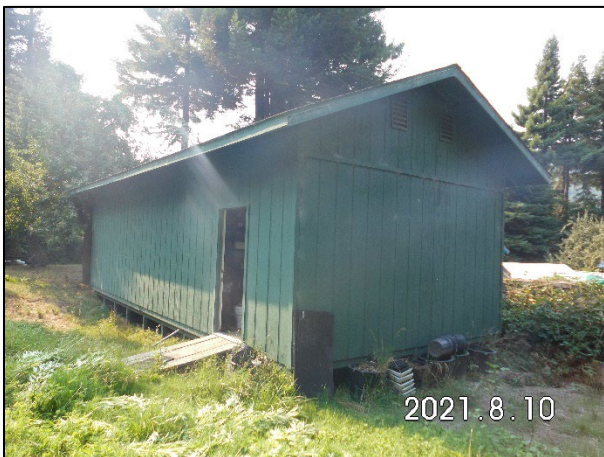
CHALLENGES

Deceased Property Owner(s)

One challenge that became a priority to deal with in 2021 were properties with deceased owners and no heirs. Since the Code Enforcement process is designed to hold the property owners responsible for public nuisances and violations on their property, it becomes difficult to make progress on a case when there is no one stepping forward to take responsibility for a property. Code Enforcement is beginning to work with the Public Administrator who is responsible for overseeing probate of an estate when the heirs decline to act, or when there are no known heirs, or when appointed to do so by the Superior Court. Of the 13 cases listed above that are ready for county abatement, three of them have deceased owners and no identifiable heirs.

Unpermitted Buildings Used in Unpermitted Cannabis Operations

An issue related to the challenges of enforcing on indoor cannabis operations is how to deal with buildings and infrastructure that are part of an unpermitted cannabis operation. HCC section 314-55.4.6.6 Site Restoration Upon Termination or Abandonment of Commercial Cannabis requires all materials, equipment and improvements on the site that were devoted to cannabis activities to be removed when a permit application is withdrawn, abandoned or terminated. Code Enforcement has used this section of HCC as guidance on how to handle



unpermitted cannabis operations as well. It has been the practice of Code Enforcement to require the site to be returned to pre-cannabis conditions. Code Enforcement typically requires all infrastructure associated with the unpermitted cannabis operation to be removed, which includes demolition of any unpermitted buildings used for indoor cultivation or operation. This practice has received increased opposition because property owners often wish to retain the unpermitted buildings they have invested in.

Many property owners propose obtaining after-the-fact permits for the buildings they want to keep, by stating alternate future uses for the building.

Trend Toward Indoor Cultivation

Code Enforcement staff has seen a trend indicating property owners have moved their operations indoors into unpermitted buildings. There are several instances where there is a new unpermitted building in the exact location where a previous outdoor cultivation operation once was. Of the 120 law enforcement search warrants Code Enforcement participated in, 63 of them were for indoor operations.
