NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The Humboldt County Administrative Officer, or a designee thereof, is hereby is authorized to execute and deliver, in accordance with any and all applicable local, state and federal laws, regulations and standards, Cooperative Fire Programs Fire Protection Reimbursement Agreement No. 1CA05359, and any amendments thereto, along with any and all other certifications, agreements and documents required or deemed necessary or appropriate for the County to accept and secure its obligations thereunder.
- 2. The County hereby certifies and represents that it will accept CalFIRE's provision of fire protection services in a manner consistent, and in compliance, with the terms and conditions set forth in Cooperative Fire Programs Fire Protection Reimbursement Agreement No. 1CA05359, as well as any and all applicable local, state and federal laws, regulations, standards and contractual requirements.
