**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS APPROVING THE
MEMORANDUM OF UNDERSTANDING FOR HUMBOLDT DEPUTY SHERIFF ORGANIZATION
NON-MANAGEMENT UNIT 6**

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment, and conditions of employment of County employees by resolution; and

WHEREAS, on December 14, 2021 the Board of Supervisors adopted Resolution No. 21-147, providing for the implementation of the 2021 - 2024 of Memorandum of Understanding for the Humboldt Deputy Sheriff Organization Non-Management Unit 6; and

WHEREAS, the Board of Supervisors desires to adopt a new resolution approving and providing for the implementation of the 2025 – 2026 Memorandum of Understanding for the Humboldt Deputy Sheriff Organization Non-Management Unit 6; and

WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS; and

NOW, THEREFORE, IT IS HEREBY PROCLAIMED that the attached Memorandum of Understanding (Attachment 1) for the term of 2025 – 2026 for the Memorandum of Understanding between the County of Humboldt and the Humboldt Deputy Sheriff Organization Non-Management Unit 6 is hereby adopted.
