I. GENERAL:

- 1. Water service is available upon payment of applicable fees.
- 2. Applicant to submit engineered utility plans for district approval. All design and construction per District Design & Construction Standards dated Sept, 2016.
- 3. Applicant to enter into a Main Extension Agreement with District.
- 4. Applicant to provide access and utility easements over all District facilities.

II. WATER:

- 1. All fire hydrant locations shall be as approved by Humboldt Bay Fire and HCSD.
- 2. An 8" diameter water main extension within Elk River Road across the frontage of the project is required.
- 3. No water services to be located in a driveway.
- 4. Per the tentative map, it appears proposed lot 5 has a water tank on it. If the tank is to remain, lot 5 will be required to have a private water backflow prevention device.
- 5. Due to the elevation of the building sites as shown on the

tentative map and the existing water pressure available from the public water system, these proposed lots may require a private water booster pump station which would also require a private water backflow prevention device.
