1. What is your familiarity with public agency Budgeting?

I was the Fire Chief of the Hayfork Fire Protection District in Hayfork, CA. As such, I worked closely with the Fire Protection District board of directors. I was in charge of all aspects of the fire district—budgeting, spending, personnel matters, fleet management, scheduling, operations, training, response readiness, recruitment and retention of personnel, cooperation with outside agencies, etc. Budgeting fell squarely on my shoulders. I set up a budgeting committee that maintained a budget for all District needs. I oversaw that committee. We met regularly and produced a draft budget, a final budget, and held mid-year budget reviews in case we needed to produce an amended budget. I am quite familiar with public agency budgeting.

2. Describe your experience with county government.

I have been employed by several local government agencies. I worked for the City and County of San Francisco for a number of years. I was employed by the Sacramento Metropolitan Fire District and the Hayfork Fire Protection District, both of which were special districts. I have worked directly with the board of directors of the SMFD and the HFPD. Although I never worked directly for the County Board of Supervisors in San Francisco, I worked on special projects in the San Francisco Fire Department that were completed in cooperation with City Hall and the Board of Supervisors.

3. Why are you interested in serving on the Citizens' Advisory Committee on Measure Z Expenditures?

I am a resident of Humboldt County. I am an active participant in my community. I am a member of the Back Country Horsemen of California (Redwood Chapter), I am a member of the Humboldt Wild Swimmers (a group of locals that swim in Humboldt Bay and some of the local lagoons), I am a member of the College of the Redwoods teaching community (I teach Fire Technology part-time at CR), I am in the process of becoming a Red Cross Disaster Assistance Team Leader through the Eureka Red Cross Warehouse, I am a volunteer Firefighter/Paramedic with the Loleta Volunteer Fire Department, I am in the process of becoming a member of the Ferndale Masonic Lodge (a philanthropic organization), and I am a retired fire service officer. I bring to the table a perspective of a local resident who would like to see the community enhanced with improved public safety and the perspective of a lifelong public safety officer. I would like to have some influence on how the Measure Z money is distributed for our public safety in Humboldt County.
