Hi Everyone,

I enjoyed talking with you all last week, and I wanted to get back to you on the programmatic questions that came up for Brownfields RLF grants.

- First of all, RLF loans can be transferred, and the entity responsible for repaying the loan does not have to own the site where the cleanup work was conducted.
- In terms of transferring a loan, it's recommended that an addendum to the loan be created to ensure (1) the new entity conducting the repayment is clearly signing on to the original loan agreement and (2) loan collateral is covered (as proof of collateral is a grant requirement). Other loan transfer options preferred by a grantee that address all grant requirements are acceptable as well.

Please let me know if you further discuss this, questions I haven't addressed, or anything else we covered during the meeting.
