SUBJECT: F. PUBLIC COMMENT NON-AGENDA ITEMS (BOS Meeting 9/23/25)

Dear Supervisors, Administration and County Health Department,

My name is Julie Threet and I am a former healthcare worker from Butte County who traveled here today to ask that you stop administration of the deadly COVID vaccine in your County and notify your citizens of the dangers. I am traveling from County to County with another whistleblower, Ronald F Owens Jr. to warn as many of our fellow citizens as possible..

I have given my testimony to elected officials in 30 counties a total of 83 times traveling 10,889 miles to: Butte County, Santa Clara, Shasta, Glenn, Colusa, Tehama, Marin, Nevada, Plumas, Sacramento, Lake, Yuba, Sutter, Monterey, Tuolumne, San Francisco, Calaveras, Mariposa, Mendocino, Merced, Ventura, San Benito, Mono, San Mateo, Modoc, Sierra, Lassen, Yolo, Placer, Tulare and Siskiyou.

I have also given testimony to the California Board of Pharmacy who is responsible for Consumer Protection a total of 11 times in Sacramento.

This proves how committed I am to my fight for justice and to urge those responsible for vaccine administration to take appropriate action.

**FOR THE RECORD, I am vaccine injured myself by the COVID-19 vaccine and have a VAERS Report filed:**

**MY HEALTHCARE WORK IN BUTTE COUNTY INCLUDED FIVE YEARS AS A PATIENT ADVOCATE AND MEMBER OF VOLUNTEER SERVICES BOARD OF DIRECTORS FOR ENLOE MEDICAL CENTER, AND WORKING AT THE BUTTE COUNTY PUBLIC HEALTH MASS VACCINATION CLINICS IN 2021 HELPING ADMINISTER THE VACCINES.**

**The hardest thing I had to do once I realized I was vaccine-injured was to ADMIT THAT I WAS BAMBOOZLED. I was lied to about the safety of this product. Once you do that, you should want to get to the bottom of who was responsible and seek justice.**

*AS OF LAST WEEK, THE CDC ISSUED NEW GUIDANCE FOR THE COVID VACCINE THAT IS DIFFERENT THAN THE NEW RULES ISSUED BY NEWSOM UNDER AB144 – WHAT WILL HUMBOLDT COUNTY COMMUNICATE?*

**On Friday, 9/19, the Advisory Committee on Immunization Practices (ACIP) met and discussed a lot of research proving harm and lack of informed consent. At the end of the meeting they voted to adjust the guidance to include strong language around “individual-based and shared-clinical decision making” rather than the universal for all approach.**

#### **COVID-19 Vaccines – Vote #4**

**The pediatric and adult immunization schedules for administration of FDA-approved COVID-19 vaccines should be updated as follows:**




- **Adults 65 and older:** Vaccination based on individual-based decision-making\*
- **Individuals 6 months to 64 years:** Vaccination based on individual-based decision-making—with an emphasis that the risk-benefit of vaccination is most favorable for individuals who are at an increased risk for severe COVID-19 disease and lowest for individuals who are not at an increased risk, according to the CDC list of COVID-19 risk factors.

*\*Also known as shared clinical decision making.*

Also last week, Governor Newsom signed AB144 which included guidance for vaccines – essentially to maintain all guidelines prior to the current Administration on 1/1/2025 and put CDPH in control of the immunization guidance going forward (will no longer follow the CDC). Here’s the guidance for the new guidance for the respiratory vaccines for California:

1. COVID-19 vaccine is available for persons 6 months and older.  
2. Protect infants with either prenatal RSV vaccine or infant dose of nirsevimab or clesrovimab.

In addition to the new guidance on the COVID-19 vaccine, the Committee changed the recommendations for the MMRV vaccine. The combination shot is no longer recommended for children under 4. This applies to the Vaccines for Children program.

Dear Ms. Scott,

Please forward this letter to CEO Sonja Bjork and the leadership team at Partnership HealthPlan of California.

I am writing both as a Partnership member and as a professional forensic accountant and business advisor with the Small Business Development Center. My intent is twofold: (1) to request immediate care coordination for my own case, and (2) to offer my professional services as an example and potential resource for how Partnership could improve care delivery in Humboldt County.

### My Experience as a Patient

I have Multiple Sclerosis. I have been hospitalized repeatedly in Humboldt, yet I cannot access appropriate care. The only neurologist available in Humboldt refuses to prescribe MS medications—even though I was previously on treatment through Kaiser with no disease progression while on medication.

Because of my MS, I stop speaking mid-sentence and cannot reliably communicate by phone. This makes navigating phone trees impossible, yet Partnership provides **no accessible email pathway for patients on its website**. For over a month, I have emailed Humboldt contacts with no response. The result is that I remain without treatment, without a neurologist, and without a care coordinator, despite referrals from my primary care provider, therapist, and cardiologist.

### The Larger Problem

This is not only my story—it is the reality for many patients in Humboldt. The current system costs millions in unnecessary hospitalizations, while failing to provide continuity of care. I have personally used AI to analyze my MRI scans, and it correctly identified symptoms my providers dismissed. Imagine if Partnership invested in modern medical AI and data systems that integrated patient history, hospital visits, and test results to give doctors clear, evidence-based summaries. The cost savings and patient outcomes would be transformative.

### My Professional Offer

As a forensic accountant and consultant, I specialize in uncovering inefficiencies and creating pathways to sustainability. I advise businesses every day on how to streamline operations, reduce costs, and improve outcomes. I am offering myself as both an example of what patients endure under the current system **and** as a professional resource to help Partnership evaluate and fix these systemic failures.

With a six-month review, I could identify where money is being wasted, outline reforms to reduce costly "doctor-to-doctor" pass-throughs, and create a pathway that both improves patient care and frees up funds to recruit and retain higher-quality providers.

### **My Immediate Request**

1. Assign me a Care Coordinator immediately so I can access MS care without being trapped in referral loops.
2. Commit to providing patients with a written communication pathway (email or portal) so those of us who cannot use phones are not left voiceless.
3. Consider my offer of professional collaboration to support Partnership's mission and fix what is currently a tragedy of wasted money and worsening health outcomes in Humboldt.

Partnership has an opportunity here: not only to correct a failure in one patient's case, but to set an example of how innovation and accountability can transform rural healthcare delivery.
