WHEREAS, the U.S. Fish and Wildlife Service (FWS) manages the North Unit of the Humboldt Bay National Wildlife Refuge (refuge), situated north of Arcata Bay and along the western side of Mad River Slough in Humboldt County; and

WHEREAS, the FWS manages the refuge to protect migratory birds, wetland habitat, and endangered species, and the refuge also provides open space and recreational opportunities to the local population including hunting, fishing, wildlife viewing, photography, and environmental education; and

WHEREAS, the FWS is seeking approval and funding from the Migratory Bird Conservation Commission (MBCC) for the purchase of a tract situated in Humboldt County, within the approved boundary of the refuge, and identified herein as APN or Parcel 506-291-014-000 (the Property); and

WHEREAS, the MBCC requires approval by the Governor before it will fund an acquisition, and that approval authority, in California, has been delegated to the Executive Director of the California Fish and Game Commission (FGC), which requires as a condition of approval, a resolution of support from the county in which the acquisition will happen; and

WHEREAS, FWS is seeking support from Humboldt County with regard to the acquisition.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Humboldt County that the Humboldt County Board of Supervisors supports the acquisition of Parcel 506-291-014-000 by the U.S. Fish and Wildlife Service for addition to the Humboldt Bay National Wildlife Refuge.
