**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AMENDING
RESOLUTION NO. 18-81 (MEMORANDUM OF UNDERSTANDING FOR AMERICAN
FEDERATION OF STATE, COUNTY & MUNICIPAL EMPLOYEES)**

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

WHEREAS, on August 21, 2018, the Board of Supervisors adopted Resolution No. 18-81, providing for the implementation of the October 1, 2017 – December 31, 2020 Memorandum of Understanding for designated American Federation of State, County & Municipal Employees; and

WHEREAS, the Board of Supervisors desires to amend Resolution No. 18-81, providing for the implementation of the October 1, 2017 – December 31, 2020 Compensation Plans for designated American Federation of State, County & Municipal Employees.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors approves amendments to Resolution No. 18-81 to:

1. Adopt the new classification of Crime Analyst (class #1399, salary range 419) into the classification plan found at Appendix A of the July 1, 2017 – December 31, 2020 American Federation of State, County & Municipal Employees (AFSCME) Memorandum of Understanding effective immediately.
2. This change shall become effective immediately following Board approval of this Resolution.
