ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT AMENDING SECTIONS 421-2 THROUGH 421-5, RELATING TO STOP SIGNS IN THE EUREKA, FORTUNA AND MCKINLEYVILLE AREAS; AMENDING SECTIONS 422-3, 422-5 AND 422-8, RELATING TO SPEED LIMITS IN THE EUREKA AND HYDESVILLE AREAS; AMENDING SECTIONS 431-24, 431-34, 431-36, 431-63, 431-65 AND 431-78, RELATING TO PARKING RESTRICTIONS IN THE EUREKA, LOLETA, MCKINLEYVILLE AND ARCATA AREAS; ADDING SECTIONS 431-35 AND 431-61.1, RELATING TO PARKING RESTRICTIONS IN THE ARCATA AND EUREKA AREAS; AND AMENDING SECTION 435-3, RELATING TO BICYCLE LANES IN THE MCKINLEYVILLE AREA OF TITLE IV, OF THE HUMBOLDT COUNTY CODE.

ORDINANCE NO. 2633

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1. Sections 421-2 through 421-5 of Chapter 1 of Division 2 of Title IV of the Humboldt County Code are hereby amended as shown on the attached pages.

SECTION 2. Sections 422-3, 422-5 and 422-8 of Chapter 2 of Division 2 of Title IV of the Humboldt County Code are hereby amended as shown on the attached pages.

SECTION 3. Sections 431-24, 431-34, 431-36, 431-63, 431-65 and 431-78 of Chapter 1 of Division 3 of Title IV of the Humboldt County Code are hereby amended as shown on the attached pages.

SECTION 4. Sections 431-35 and 431-61.1 are hereby added to Chapter 1 of Division 3 of Title IV of the Humboldt County Code as shown on the attached pages.

SECTION 5. Section 435-3 of Chapter 5 of Division 3 of Title IV of the Humboldt County Code is hereby amended as shown on the attached pages.

SECTION 6. This ordinance shall take effect and be in force thirty (30) days from the date of its passage. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of Humboldt, State of California.

CHAPTER 1

BOULEVARD STOPS

421-2. Designation of Various Stop Intersections.

Authorization. Pursuant to the authority contained in § 21101(b) and 21354 of the Vehicle Code of California, the following intersections are designated as stop intersections:

(22.6) Highland Circle (County Road No. 3K585) southbound at its intersection with Edgewood Road (County Road No. 3K580). (Ord. _____, § _____, / /2019)

(25.1) Horrell Avenue (County Road No. 4M196) westbound at its intersection with Little Pond Street (County Road No. 4M198). (Ord. _____, § _____, / /2019)

421-4. Designation of Various Stop Intersections.

CHAPTER 2 SPEED LIMITS

422-3. Five Miles per Hour (10 km/h) Speed Limit.

The speed limit for the highways or portions thereof designated as follows is determined and declared to be five (5) miles per hour (10 km/h): (Ord. 2351, § 9, 12/06/2005)

(1) Bridge No. 4C-180 (Viaduct Bridge). Pursuant to Vehicle Code § 21109, 22403, the prima facie speed limit for Viaduct Bridge (County Bridge No. 4C-180) on Ishi Pishi Road (County Road No. 9R100) is hereby determined and declared to be five (5) miles per hour (10 km/h) for all buses, motor trucks and truck tractors. (Ord. 881, § 1, 10/3/1972; Ord. 2351, § 9, 12/6/2005)

(2) Bridge No. 4C-48 (Zanes Road Covered Bridge). Pursuant to Vehicle Code § 21109, 22403, the prima facie speed limit for Zanes Road Covered Bridge (County Bridge No. 4C-48) on Zanes Road (County Road No. 3J280) from Post Mile 0.087 to Post Mile 0.114 (P.K. 0.140 to P.K. 0.183) is hereby determined and declared to be five (5) miles per hour. (Ord. , § , / /2019)

(3) Bridge No. 4C-47 (Elk River Bridge). Pursuant to Vehicle Code § 21109, 22403, the prima facie speed limit for Elk River Bridge, also known as the Berta Road Covered Bridge, (County Bridge No. 4C-47) on Berta Road (County Road No. 3J260) from Post Mile 0.140 to Post Mile 0.166 (P.K. 0.225 to P.K. 0.267) is hereby determined and declared to be five (5) miles per hour. (Ord. , § , / /2019)

422-5. Fifteen Miles per Hour (25 km/h) Speed Limit.

The speed limit for the highway or portions thereof designated as follows is determined and declared to be fifteen (15) miles per hour (25 km/h):

(1) Bridge No. 4C-29. Pursuant to Vehicle Code § 22403 and 22404, the prima facie speed limit for Bridge No. 4C029 (Salt River Bridge), which bridge crosses the Salt River on Fulmore Road (County Road No. 2H040), is hereby determined and declared to be fifteen (15) miles per hour (25 km/h) for all vehicles. (Ord. 1276, § 1, 9/26/1978)

(1.1) Johnson Road (County Road No. 4G060) from Post Mile 0.034 to Post Mile 0.306 (P.K. 0.054 to P.K. 0.492) is hereby determined and declared to be fifteen (15) miles per hour when children are present. (Ord. , § , / /2019)

(2) Machi Road (County Road 4A032). Pursuant to Vehicle Code § 22358.3, the prima facie speed limit for Machi Road, is hereby determined and declared to be fifteen (15) miles per hour (25 km/h) for all vehicles. (Ord. 2300, § 2, 5/6/2003)

422-8. Twenty-Five Miles per Hour (40 km/h) Speed Limit; Business or Residence District Speed Limit.

In accordance with Vehicle Code § 22352, the following described portions of County roads are determined to be in a business or residence district. The prima facie speed limit for the following described portions of County roads is twenty-five (25) miles per hour (40 km/h):

(22.5) Cypress Avenue (County Road No. 3K270) from P.M. 0.024 to P.M. 0.150 (P.K. 0.038 to P.K. 0.241). (Ord. § , / /2019)

(47.5) Holly Street (County Road No. C3J670) - from P.M. 0.010 to P.M. 0.190 (P.K. 0.016 to P.K. 0.305). (Ord. § , / /2019)

431-24. Parking on Elk River Road.

(a) The parking of vehicles on Elk River Road (County Road No. F3J300) is hereby prohibited between the hours of 10:00 p.m. and 5:00 a.m. from Post Mile 0.0 to Post Mile 0.02 (P.K. 0.0 to P.K. 0.03). (Ord. 2337, § 2, 1/18/2005)

(b) The parking of vehicles is hereby prohibited on both sides of Elk River Road (County Road No F3J300) from Post Mile 1.314 to Post Mile 1.490 (P.K. 2.114 to P.K. 2.397) at all times. (Ord. § , / /2019)

431-34. Parking on Fern Street.

(a) The parking of vehicles is hereby prohibited at all times on the north side of Fern Street (County Road No. 3K210) between Post Mile 0.426 and Post Mile 0.440 (P.K. 0.69 and P.K. 0.71) and on the north side of Fern Street (County Road No. 3K210) between Post Mile 0.0 and Post Mile 0.014 (P.K. 0.0 and P.K. 0.023) and on the south side of Fern Street (County Road No. 3K210) between Post Mile 0.41 and Post Mile 0.44 (P.K. 0.66 and P.K. 0.71) and on the south side of Fern Street (County Road No. 3K210) between Post Mile 0.0 and Post Mile 0.012 0.026 (P.K. 0.0 and P.K. ~~0.019~~ 0.040). (b) Parking is restricted to a maximum of one hour at all times on the north side of Fern Street (County Road No. 3K210) between Post Mile 0.014 and Post Mile 0.035 (P.K. 0.02 and P.K. 0.06) and on the south side of Fern Street (County Road No. 3K210) between Post Mile 0.00 and Post Mile 0.026 (P.K. 0.00 and P.K. 0.04). (Ord. 2370, § 1, 9/19/2006; Ord. 2386, § 3, 5/1/2007; Ord. § , / /2019)

(c) The parking of vehicles is hereby prohibited at all times on both sides of Fern Street (County Road No. C3K210) from Post Mile 0.23 to Post Mile 0.25 (P.K. 0.37 to P.K. 0.40). (Ord. 2565, § 2, 11/1/2016)

431-35. Parking on Fickle Hill Road.

The parking of vehicles is hereby prohibited at all times on both sides of Fickle Hill Road (County Road No. C5J040) from Post Mile 0.000 to Post Mile 0.248 (P.K. 0.000 to P.K. 0.399) and both sides of Fickle Hill Road

(County Road No. 5J040) from Post Mile 10.819 to Post Mile 11.150 (P.K. 17.411 to P.K. 17.944). (Ord. _____, § _____ / 2019)

431-36. Parking on Freshwater-Kneeland Road.

(a) The parking of vehicles is hereby prohibited from the hour of 8:00 a.m. to the hour of 4:00 p.m. on the southerly side of Freshwater-Kneeland Road (County Road No. F6F060) in that area from the west side of Garfield School driveway westward for a distance of 20 feet (60.09 meters). The restriction provided herein shall not be applicable on Saturdays, Sundays or legal holidays and shall be applicable only from the 1st day of September until the 15th day of June of any year. (Ord. 833, § 1, 3/14/1972)

(b) The parking of vehicles is hereby prohibited at all times on Freshwater-Kneeland Road (County Road No. F6F060) from P.M. 37.84 to P.M. 37.92 (km 59.94 to km 60.06). (Ord. 1799, § 2, 6/9/1987)

(c) The parking of vehicles is hereby prohibited at all times on the east side of Freshwater Road (County Road No. F6F060) from Post Mile 40.750 to Post Mile 40.870 (P.K. 65.580 to P.M. 65.773). (Ord. _____, § _____ / 2019)

431-61.1 Parking on John Hill Road.

The parking of vehicles is hereby prohibited at all times on the east side of John Hill Road (County Road No. 3K710) from Post Mile 0.124 to Post Mile 0.131 (P.K. 0.199 to P.K. 0.210), and on the west side of John Hill Road (County Road No. 3K710) from Post Mile 0.166 to Post Mile 0.172 (P.K. 0.267 to P.K. 0.276). (Ord. _____, § _____ / 2019)

431-63. Parking on Loleta Drive.

(a) The parking of vehicles is hereby limited to 15 minutes between 8:00 a.m. and 5:00 p.m. daily, excepting Sundays and holidays, on the south side of Loleta Drive (County Road A3H200) from Post Mile 0.048 (P.K. 0.077) to Post Mile 0.049 (P.K. 0.079). (Ord. 2337, § 2, 1/18/2005)

(b) The parking of vehicles is hereby prohibited at all times on the north side of Loleta Drive (County Road No. C3H200) from Post Mile 0.424 to Post Mile 0.434 (P.K. 0.682 to P.K. 0.698). (Ord. _____, § _____ / 2019)

431-65. Parking in McKinleyville.

(a) The parking of vehicles is prohibited at all times in each of the following locations:

(6) *Murray Road.* The parking of vehicles is hereby prohibited on the north side of Murray Road (County Road C3M020) from Post Mile 0.05 through Post Mile 0.24 (P.K. 0.08 through P.K. 0.39) and on the north side from Post Mile 0.010 to Post Mile 0.028 (P.K. 0.016 to P.K. 0.045) and on the north side from Post Mile 0.58 through Post Mile 0.93 (P.K. 0.93 through P.K. 1.50) and on the south side from Post Mile 0.35 through Post Mile 0.66 (P.K. 0.56 through P.K. 1.06) and on the south side from Post Mile 0.70 through Post Mile 0.75 (P.K. 1.13 through P.K. 1.21) and on the south side from Post Mile 0.91 through Post Mile 1.10 (P.K. 1.46 through P.K. 1.77). 431-78. Parking on Ocean View Drive.

The parking of vehicles is hereby prohibited at all times on the west side of Ocean View Drive (County Road No. 3P020) from Post Mile 0.00 to Post Mile ~~0.27~~ 0.20 (P.K. 0.00 to P.K. ~~0.43~~ 0.32) (Ord. 2578, § 1, 9/12/2017; Ord. _____, § _____ / 2019)

CHAPTER 5
BICYCLE LANES

435-3. Establishment of Class II Bicycle Lanes.

The following Class II bicycle lanes are hereby established:

(q) Along both sides of Tasi Lane in McKinleyville (County Road No. 4L814) in its entirety from Sutter Road, Post Mile 0.000 (P.K. 0.000), to Dogwood Street, Post Mile 0.247 (P.K. 0.397). (Ord. _____, § _____ / 2019)
