NOTICE IS HEREBY GIVEN that the Humboldt County Code Enforcement Unit has taken the actions described in "Attachment A – Actions Required to Abate Nuisance" to correct the condition or conditions found to constitute a nuisance on the above-referenced property situated in the County of Humboldt, State of California, as described in "Attachment B – Legal Description."

NOTICE IS FURTHER GIVEN that the Code Enforcement Unit will seek to levy a nuisance abatement assessment against the affected property in the amount of **Two Hundred and Seventeen Thousand Eight Hundred Thirty Four Dollars and Eighty Six Cents (\$217,834.86)** in order to recover the abatement costs, administrative costs and/or attorney's fees, as described in "Attachment C – Account of Costs Incurred and Proceeds Received," that were incurred to correct the condition or conditions found to constitute a nuisance on the affected property.

NOTICE IS FURTHER GIVEN that you may file with the Code Enforcement Unit an objection to the proposed assessment within ten (10) calendar days after service of this Notice of Nuisance Abatement Assessment.

NOTICE IS FURTHER GIVEN that an objection to the proposed assessment must be prepared using the

NOTICE IS FURTHER GIVEN that, upon receipt of an objection to the proposed assessment, the Code Enforcement Unit shall set the matter for hearing before the Humboldt County Board of Supervisors, and issue a Notice of Cost Recovery Hearing as set forth in Humboldt County Code Section 351-18.


NOTICE IS FURTHER GIVEN that the date of the Cost Recovery Hearing shall be no sooner than fifteen (15) calendar days after the date on which the Notice of Cost Recovery Hearing is served.

NOTICE IS FURTHER GIVEN that the proposed assessment shall be deemed final and summarily approved by the Humboldt County Board of Supervisors without holding a Cost Recovery Hearing, if an objection to the proposed assessment is not filed within ten (10) calendar days after service of this Notice of Nuisance Abatement Assessment.

NOTICE IS FURTHER GIVEN that the final nuisance abatement assessment, as approved by the Humboldt County Board of Supervisors, may become a charge against the affected property and may be collected at the same time and in the same manner, and shall be subject to the same penalties, interest and procedures of foreclosure and sale in the case of delinquency, as is provided for ordinary property taxes.

NOTICE IS FURTHER GIVEN that the final nuisance abatement assessment, as approved by the Humboldt County Board of Supervisors, may also become a charge against the affected property which has the same force, effect and priority of a judgment lien governed by the provisions of California Code of Civil Procedure Sections 697.310, et seq., and may be extended as provided in California Code of Civil Procedure Sections 683.110, et seq.

LEGAL DESCRIPTION

That real property situate in the County of Humboldt, State of California, described as follows:

PARCEL ONE

BEGINNING on the Section line at a point distant thereon 1320.00 feet Northerly from the Southeast corner of said Section;

thence Southerly along said Section line, 12 feet to a point on the Southerly line of a lane 12 feet wide;

thence along the Southerly line of said lane, North 89 degrees 31 minutes West, 405 feet to an iron pipe monument, which monument is the TRUE POINT OF BEGINNING of the parcel to be here described:

thence from said true point of beginning continuing along said Southerly line of the County Road;

thence Southeasterly along said Easterly line, 146.94 feet to the most Southerly corner of the parcel of land conveyed to Lewis Murrish and wife, by Deed dated July 31, 1954, and recorded in Book 302 of Official Records, Page 31, Humboldt County Records;

thence North 53 degrees 28 minutes East, 62 feet;

thence North 02 degrees 14 minutes East, 25 feet 6 inches to the South-easterly line of the land conveyed to Murrish and wife, by Deed date February 17, 1950, and recorded in Book 122 of Official Records, Page 269, Humboldt County Records;

thence North 53 degrees 28 minutes East to a point which bears South 02 degrees 14 minutes West from the true point of beginning;

thence North 02 degrees 14 minutes East, 35.38 feet to the true point of beginning.

PARCEL TWO

An easement to drill and excavate for water resources, to erect and maintain a water well and pumps, and to install and maintain a water pipeline, all as conveyed by Carroll Brownfield and wife, to Rodney T. Church and others, by Deed dated February 14, 1980, and recorded March 7, 1980, in Book 1605 of Official Records, Page 1285, as Recorder's Serial No. 4693, Humboldt County Records.
