Dear Mr. Hames:

On July 2, 2015, you were served with a Notice and Order to Abate Unlawful Marijuana Cultivation in the Inland Zone. You did not abate the nuisance as required by the notice and order. Consequently, on September 14, 2015, the Humboldt County Code Enforcement Unit and the Humboldt County Sheriff's Department removed and disposed of the marijuana being illegally cultivated.

Per Humboldt County Code Section 314-55.2.8.8, the officer tasked with enforcing the County's small parcel, medical marijuana ordinance is required to keep an accounting of the costs associated with any abatements he conducts. The accounting for your above described parcel has been delivered to the Humboldt County Board of Supervisors (Board) as required.

A hearing has been scheduled on **June 14, 2016 at 1:30 PM** or as soon thereafter as the matter can be heard before the Board in the **Supervisor's Chambers, County Courthouse Building, 825 Fifth Street, Eureka, California**. At said time and place the Board will hear and consider any objections and protests to the accounting. You may appear with an attorney or other representative, call and cross-examine witnesses, and present evidence on your behalf. A copy of the enforcing officer's cost accounting is attached to this letter.
