**RESOLUTION NO. 24 – 85**

**AUTHORIZING CONSOLIDATION AND PERFORMANCE OF SERVICES BY THE REGISTRAR OF VOTERS IN ELECTIONS TO BE HELD WITHIN HUMBOLDT COUNTY**

**WHEREAS**, the County of Humboldt has received requests from the City of Arcata, City of Blue Lake, City of Eureka, City of Ferndale, City of Fortuna, City of Rio Dell, City of Trinidad, Redwoods Community College District, Fortuna Union High School District, Kneeland Fire Protection District, Peninsula Community Services District, Arcata School District, Ferndale Unified School District, Cutten School District, Arcata Protection District, and the Humboldt County Board of Education pursuant to California Elections Code Sections 10403 and 10002 to consolidate an election; and

**WHEREAS**, two or more elections called by a public district, city, county or political subdivision on the same day, in the same territory, may be consolidated upon order of the Board of Supervisors of the County of Humboldt pursuant to California Elections Code Section 10400, and the Registrar of Voters of the County of Humboldt in providing such services as requested will be reimbursed for all costs incurred pursuant to California Elections Code section 10002; and

**WHEREAS**, the deadline to receive requests from a district, city, or other political subdivision for an election to be consolidated with a statewide election is 88 days prior to the date of the election pursuant to California Elections Code section 10403; and

**WHEREAS**, it was formerly the practice prior to each statewide election to request the Board of Supervisors of Humboldt County approve the consolidation request of each district, city, or other political subdivision individually.

**NOW, THEREFORE, IT IS HEREBY PROCLAIMED** the Board of Supervisors of the County of Humboldt, State of California, hereby consolidate the elections as requested and will permit the Registrar of Voters to provide services as requested and the Registrar of Voters will be reimbursed in full for these services; and

**IT IS FURTHER PROCLAIMED AND ORDERED** pursuant to California Elections Code Section 10400, the Registrar of Voters of Humboldt County may approve requests for consolidation of an election where two or more elections called by a public district, city, county or political subdivision on the same day, in the same territory, within Humboldt County provided that reimbursement to the County for election services will be rendered.
