Good morning,

I'm trying to make sure I can participate remotely via Zoom for today's Board of Supervisors, but to make sure my public comment will be heard, here it is in written form. Seems like Zoom requires a password but I didn't find one from County's website.

My name is Katja Kesti. I'm based in Finland, and I'm here to talk about our hopes of rebuilding the John Haynes Memorial Hall for Veterans.

John Haynes was my first cousin twice removed. When he went missing in the Philippines on his flight on the eighth of December nineteen forty-one, during his service as a pilot in the US Air Force, my great-grand-aunt Mrs. Esther Underwood lost her last living child. She had already lost three boys before John.

We can all cherish memories of our loved ones in our hearts, but we also need a place to go—to show our respect, to give and receive support and love, to share stories, joy, hope and grief.

John's remains were never found, so he doesn't have a grave, and my great-grand-aunt had no place to go to remember him. So, she made a decision.

She donated a property as a legacy in memory of John. This legacy would turn out to be the heartbeat of the community, the Memorial Hall, a home away from home for every local veteran.

We cannot overlook our basic human need for belonging, to be seen, and to be heard. For veterans, it is the community which was gently held by the John Haynes Memorial Hall.

For decades, within those minty green walls, stories were told and experiences shared by those who understand the realities of service—stories that can only be shared in a safe space.

As far as I know, the Memorial Hall has been a very important place for local veterans. I think that is something my great-grand-aunt had in mind—to build a place carrying her son's name that welcomes all veterans and their families.

As an extended family member of John Haynes and his mother Esther, it is important to me to honor his legacy by asking for the rebuilding of The John Haynes Memorial Hall, which can serve as a safe space for local veterans to gather and call home once again.

By advocating for the rebuilding, I also aim to honor and show my respect to local veterans, all of whom deserve safety and stability.
