PROCLAMATION

OF THE BOARD OF SUPERVISORS COUNTY OF HUMBOLDT



WHEREAS, bicycle travel is an effective means to increase physical activity, improve public health, improve air quality, and reduce traffic congestion and noise; and

WHEREAS, bicycle commuting benefits both employees and employers through better employee health and fitness; reduced commuting, parking and health care costs, lower employee absenteeism and turnover, and increased employee productivity; and

WHEREAS, bicycling is part of the solution for addressing transportation needs, limiting impacts to infrastructure, as well as conserving energy; and

WHEREAS, the month of May is "National Bike Month" which promotes the bicycle as a means of transportation and recreation, and May is also "Clean Air Month" which promotes air quality; and

WHEREAS, the County of Humboldt leads Safe Routes to Schools efforts throughout Humboldt to improve safety and coordination for kids biking and walking to school; and

WHEREAS, the County of Humboldt leads efforts to expand our regional trail system to encourage non-motorized transportation and foster greater active living and recreation opportunities; and

WHEREAS, Bike Month Humboldt features a number of events for riders of all ages to enjoy throughout the month at various locations.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors hereby proclaims May, 2016 as Bike Month and proclaims May 4th, 2016 as Bike to School Day throughout Humboldt County, and urges all citizens to support and participate in these and other activities that contribute to the health of the community and the environment, and encourages its residents and visitors to bicycle safely and to always be aware of cyclists on our roads.
