Humboldt County, of Title IV of the Humboldt County Code

#### **RECOMMENDATIONS:**

That the Board of Supervisors:

Direct the Clerk of the Board of Supervisors to publish the pre-adoption summary of the ordinance and to post a certified copy of the full text of the ordinance in the office of the Clerk of the Board of Supervisors at least five (5) days prior to the Board of Supervisors meeting at which the ordinance will be adopted [California Government Code Section 25124 (b)(1)];
- 4. Direct the Clerk of the Board of Supervisors, within fifteen (15) days after adoption of the ordinance, to publish a post-adoption summary of the ordinance with the names of the Supervisors voting for and against the ordinance, and to post in the office of the Clerk of the Board of Supervisors a certified copy of the full text of the adopted ordinance along with the names of those Supervisors voting for and against the Ordinance [California Government Code Section 25124 (b)(1)]; and
- 5. Direct Department of Public Works staff to file the attached Notice of Exemption with the Humboldt County Clerk in accordance with the California Environmental Quality Act.

#### **DISCUSSION:**

The proposed ordinance (Attachment 1) sets the speed limit for portions of Heartwood Drive and Hiller Road in McKinleyville at twenty-five (25) miles per hour, it also sets the speed limits for certain portions of Main Street in Scotia at twenty-five (25), thirty-five (35) and forty (40) miles per hour. The proposed ordinance also prohibits parking at certain portions of B Street, Third Street, Bridges Street, Main Street and First Street in Scotia and revises the prohibition of parking on the east side of Montgomery Street in Eureka to the west side of the street.

The Caltrans Traffic Manual states that the speed limits should normally be established at the first five (5) mile per hour increment below the eighty-fifth (85<sup>th</sup>) percentile of speed. However, in matching existing conditions with the traffic safety needs of the community, engineering judgment may indicate the need for a further reduction of five (5) miles per hour.

An Engineering Traffic Survey ("ETS") was performed on Heartwood Drive in McKinleyville and Main Street in Scotia because neither of these county roads had existing speed limits. The eighty-fifth (85th) percentile of speed on Heartwood Drive was twenty-six (26) miles per hour; therefore, staff recommends setting the speed limit at twenty-five (25) miles per hour. An ETS was performed on three (3) separate sections of Main Street in Scotia. Starting from the north end of Main Street at the south end of the Eagle Prairie Bridge to the intersection of Main Street and Bridges Street the eighty-fifth (85th) percentile of speed was thirty-six (36) miles per hour; therefore, staff recommends setting the speed limit for this portion of Main Street at thirty-five (35) miles per hour. From the intersection of Main Street and B Street, near the southern entrance to the Humboldt Redwood Company Mill, the eighty-fifth (85th) percentile of speed was twenty-six (26) miles per hour; therefore, staff recommends setting the speed limit for this portion of Main Street at twenty-five (25) miles per hour. From the intersection of Main Street and B Street to U.S. Highway 101 the eighty-fifth (85th) percentile of speed was forty-two (42) miles per hour; therefore staff recommends setting the speed limit for this portion of Main Street at forty (40) miles per hour.

Residents living on Hiller Road requested that the speed limit on Hiller Road from Ocean Drive to McKinleyville Avenue be set at twenty-five (25) miles per hour. At the present time, Hiller Road does not have a codified speed limit. At some point in time, a thirty-five (35) mile per hour speed limit sign was erected on Hiller Road, but an ordinance was never taken to the Humboldt County Board of Supervisors for codification.

California Vehicle Code Section 2352(b)(1), which has been incorporated into Section 422-8 of the Humboldt County Code, states that a speed limit of twenty-five (25) miles per hour can be enforced on any highway, other than a state highway, and in any business or residence district. The portion of Hiller Road from Ocean Drive to McKinleyville Avenue, and the property contiguous thereto, constitutes a "residence district" as defined by California Vehicle Code Section 515. Accordingly, staff recommends setting the speed limit for this portion of Hiller Road at twenty-five (25) miles per hour.

The proposed no parking zones on B Street, Third Street, Bridges Street, Main Street and First Street in Scotia were requested by the Humboldt County Department of Public Works Land Use Division as part of the finalization of the Town of Scotia's Phase II Improvement project.

Montgomery Street in the Eureka area is approximately thirty (30) feet wide which is insufficient for two-way traffic and parking on both sides of the roadway; therefore, parking must be eliminated on one (1) side

of the street. The revision of the current parking prohibition on Montgomery Street changes the no parking zone from the east side of the street, where there are several residential housing units, to the west side of the street which is adjacent to the Ace Hardware store that has a large parking facility.

The proposed ordinance is considered a project under the California Environmental Quality Act ("CEQA"). This project is categorically exempt from environmental review pursuant to Section 15301 – "Existing Facilities" and Section 15305 – "Minor Alterations in Land Use Limitations" of the CEQA Guidelines. In addition, the application of this categorical exemption is not barred by any of the exceptions set forth in Section 15300.2 of the CEQA Guidelines. A Notice of Exemption is attached hereto as Attachment 4.

# **FINANCIAL IMPACT:**

Adoption of the proposed ordinance will require the creation and installation of regulatory signs in the relevant locations. The estimated cost of manufacturing and installing the required regulatory signs is one hundred thirty dollars (\$130.00) per sign, which is covered in the Road Fund budget. Accordingly, the recommended actions will not impact the Humboldt County General Fund.

The recommended actions conform to the Board of Supervisors' Core Roles of providing for and maintaining infrastructure and creating opportunities for improved safety.

# OTHER AGENCY INVOLVEMENT:

California Highway Patrol enforces traffic laws on county maintained roads.

# **ALTERNATIVES TO STAFF RECOMMENDATIONS:**

The Board could choose to not adopt the proposed ordinance. However, this alternative is not recommended since it would not improve traffic safety in the relevant locations.

# AND SCOTIA AREAS OF HUMBOLDT COUNTY, OF TITLE IV OF THE HUMBOLDT COUNTY CODE

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1. Sections 422-7, 422-8, 422-10 and 422-11 of Chapter 2 of Division 2 of Title IV of the Humboldt County Code are amended as shown on the attached pages.

SECTION 2. Section 431-68 and 431-97.5 of Chapter 1 of Division 3 of Title IV of the Humboldt County Code is amended as shown on the attached pages.

SECTION 3. This ordinance shall take effect and be in force thirty (30) days from the date of its adoption. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of Humboldt, State of California.

Hiller Road Speed Reduction

# Director of County Roads,

I am writing to submit a request to reduce the speed limit on Hiller Road, in Mckinleyville, California 95519. The road up for reduction request is on Hiller Road. Hiller is currently 35 mph, and my neighbors and I feel this is extremely fast. I am speaking of the west side of Hiller Road, west of Mckinleyville Avenue. This side of Hiller Road is host to many tourists and visitors, and most importantly our children and pets. Hiller Road adjoins the well-known Hammond Trail, as well as the trails to ocean view trail system and dog park. Hiller Road is also location of Hiller Park, where baseball games are played, and there is a playgroud for children to congregate. There are many children that use Hiller Road as a throughway to get to their schools. Also, there are quite a few handicap citizens who frequent this road for it's convenience. Hiller is quite long from Mkcinleyville Avenue to the bottom, and lowering the speed limit to 25 mph could prevent future accidents. There are houses beside each other, as well as across from each other, on this residential road. There are many other streets in this residential area, yet Hiller Road is the only one still a dangerously fast, 35 mph. There seem to be a growing number of children in our area, and I believe this to be the answer to a community issue.
