Dear Director Ainsworth and Honorable Coastal Commissioners:

The Humboldt County Board of Supervisors would like to offer their support for the proposed extension to the existing Coast Seafood permit in an effort to continue to seek a long term agreement for future shellfish culture in Humboldt Bay.

Humboldt Bay is California's second largest bay with approximately 17,760 acres in area with about 5,650 acres of eelgrass beds and 287 acres of mariculture. The bay and surrounding lands have been the home of the Wiyot people for thousands of years. Since the 1850's the bay has been a deep water port servicing our timber industry and fishing fleet. It is widely considered one of the more pristine and productive estuaries on the west coast and we are proud of the environmental stewardship our county has played helping to protect this invaluable resource.

Humboldt Bay has a long history of mariculture and is the producer of the majority of oysters in California and proclaimed the oyster capital of California by the legislature. We support shellfish culture and its consideration as an appropriate and valuable public trust use in balance and co-existence with other public benefits such as fishing, commerce, boating, tourism, hunting and clamming. It is an important part of our economy and working waterfront that allows many people from all over California and the nation to connect with and enjoy the bounty that our rich coastline has to offer.

Our Board also recognizes the significant community investment the shellfish growers have made in their efforts to maintain and improve the water quality of Humboldt Bay. In many estuaries around the world the connection between water quality, ecosystem health, and shellfish culture is noteworthy. Had our bay not have had a strong mariculture presence for the last 100 years the bay would look significantly different than it does today; think San Francisco Bay and its loss of eelgrass. Shellfish farmers have been instrumental in preventing planned and accidental pulp mill and sewage discharges from directly entering into the bay. They continue to be strong advocates for storm water and point discharge regulations and projects essential to protecting Humboldt Bay's water quality.

Our Board recognizes the need for good resource management using sound science and responsible decisions based on that science. The shellfish industry here strives to encourage and embrace this sound science and management and has changed considerably over the years in order to minimize and eliminate negative impacts, improve ecological services and improve co-existence with other public trust uses and resources. As a result of this effort, Humboldt Bay is widely considered one of the most progressive and well managed shellfish culture areas on the West Coast.

Humboldt County and its residents continue to support this sustainable and responsible industry and would encourage the California Coastal Commission's efforts to renew Coast Seafood's existing farm and allow for efforts to continue to explore alternative methods and areas for the growth of this industry.
