GOVERNING BODY RESOLUTION FOR EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM

WHEREAS, the Humboldt County Sheriff's Office desires to participate in the Edward Byrne Memorial Justice Assistance Grant (JAG) Program Local 2025 administered by the United States Department of Justice – Office of Justice Programs (hereafter referred to as DOJ-OJP).

NOW, THEREFORE, BE IT RESOLVED that the Humboldt Board of Supervisors hereby:

1. Approves receiving grant funding from the Edward Byrne JAG Program Local 2025.
2. Authorizes the County Administrative Officer, Sheriff, Undersheriff, or Deputy Director of Financial and Support Services to submit a governing body resolution for the Edward Byrne Memorial JAG Program Local 2025, accept grant funds, and sign any required documents required for participation in the grant program.
3. Authorizes the County Administrative Officer to sign the Edward Byrne Memorial JAG Program Local 2025 Solicitation Certifications and Assurances by the Chief Executive of the Application Government.
4. Appoints the County Administrative Officer, Sheriff, Undersheriff, or Deputy Director of Sheriff's Financial and Support Services as agent to conduct all negotiations, execute and submit all documents including, but not limited to all necessary applications, strategic plans, letters of agreement, contracts, amendments, and reimbursement claims which may be necessary for obtaining federal financial assistance provided by the DOJ-OJP for the Edward Byrne Memorial JAG Program Local 2025.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

BE IT FURTHER RESOLVED that the County of Humboldt agrees to abide by the statutes and regulations governing the federal Formula Grants Program as well as the terms and conditions of the Grant Amendment set forth by the DOJ-OJP.
